It is approx. .25 acres There are no funding restrictions. It is located north of E. Virgin St., between N. Lansing Ave, and N Midland PI. and is not in a flood plain. This site has been reviewed by the City's internal Real Estate Oversight Committee and they recommended approval during the April 20th, 2022 meeting. The subsequent Utility Review found no objections with surplus application with need to retain all needed easements and all future development will meet the subdivision regulations.

RESOLUTION NO.

A RESOLUTION DECLARING THAT CERTAIN REAL PROPERTY OWNED BY THE CITY OF TULSA IS NO LONGER NECESSARY FOR ANY PUBLIC USE OR PURPOSE; AND REQUESTING THE ASSET MANAGEMENT DEPARTMENT TO EFFECT THE SALE OF SAID PROPERTY

WHEREAS, the Asset Management Department has determined that a certain real property, owned by the City of Tulsa, described below, is no longer needed for any public purpose except as hereinafter set forth; and

WHEREAS, Section 1 of Article I of the Charter of the City of Tulsa (as Revised, effective May 8, 1990) provides for the sale or other management of public property as the interest of the City of Tulsa may require; and

WHEREAS, the Subject Property was donated to the City by the Board of County Commissioners of Tulsa County and conveyed to the City by Quit-Claim Deed dated Sept. 14, 1992; and

WHEREAS, the Subject Property is vacant, and the City has been maintaining the Subject Property since acquiring it; and

WHEREAS, the Subject Property has been approved for surplus through both the City's Real Estate Oversight Committee and Engineering Services utilities review; and

WHEREAS, there are no funding restrictions to prevent the sale of Subject Property; and

WHEREAS, it is in the best interest of the City for the Subject Property to be declared surplus and to be sold upon determining the market value, as deemed appropriate by surplus policies

NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF TULSA, OKLAHOMA:

SECTION 1: That the following described property, owned by the City of Tulsa (the Subject Property) be, and the same hereby is declared to be, surplus and no longer needed for any public purpose:

Lot Nine (9), Block Five (5), LECLAIRE ADDITION to the City of Tulsa, Tulsa County, State of Oklahoma, according to the recorded plat thereof.

SECTION 2: That the Director of Asset Management, or his designee, is requested to establish a market value for the property, to assist the Mayor in the negotiation and sale of the Subject Property and to effect the sale of the Subject Property. SECTION 3: That any conveyance of the Subject Property shall be subject to all existing or desired easements, encumbrances, restrictions, reservations and other matters of record.

SECTION 4: That any conveyance of the Subject Property shall be made on an "As Is" basis.

SECTION 5: That the Mayor is requested to execute the necessary Quit Claim Deed to transfer the Subject Property.

SECTION 6: That the City Clerk be and is hereby authorized and requested to attest the signature of the Mayor to the above described deed.
