AN ORDINANCE AMENDING THE FISCAL YEAR 2022-23 BUDGET OF THE CITY OF TULSA, OKLAHOMA, TO TRANSFER AVAILABLE APPROPRIATIONS OF ONE HUNDRED TWENTY-ONE THOUSAND FOUR HUNDRED FIFTY-SIX DOLLARS AND FIFTEEN CENTS (\$121,456.15) BETWEEN ACCOUNT GROUPS WITHIN THE SEXUAL ASSAULT KIT INITIATIVE SUBFUND (SUBFUND 2420), AS FOLLOWS:

BE IT ORDAINED BY THE CITY OF TULSA:

Section 1. That the Fiscal Year 2022-23 Budget of the City of Tulsa, Oklahoma, be and it is hereby amended to transfer available appropriations of One Hundred Twenty-One Thousand Four Hundred Fifty-Six Dollars and Fifteen Cents (\$121,456.15) between account groups within the Sexual Assault Kit Initiative Subfund (Subfund 2420), as follows:
