

Policy Statement

Background Information

World Education Services (WES) is hosting the Skilled Immigrant Integration Program (SIIP) Convening October 24-25 in Washington, D.C. The Convening, the first in-person gathering since 2019, will be a space for the nearly forty state and local communities that make up the SIIP Network to gather, discuss, and engage with state and local practitioners, researchers, and policymakers. The City of Tulsa became part SIIP network when we received a technical assistance grant from World Education Services in 2020. During the grant period, we launched Flourish Tulsa, a program to support internationally trained immigrants in our community. This past summer, City of Tulsa received second technical assistance grant from WES to continue to support our internationally trained immigrants. WES will be sponsoring at least one individual per community to attend the event. Sponsorship will include: 1) travel stipend 2) hotel accommodation for two nights and 3) five meals over the two-day period.

Summation of the Requested Action

This request is for approval to accept a donation to cover the cost of all accommodations, travel, and meals for the City's Immigrant Affairs Manager to attend the 2022 SIIP Convening in DC. The value of the trip is \$1638 which includes \$550 travel stipend, \$498 for meals and \$590 for hotel (\$295 per night + taxes). This estimate does not include taxes. WES will provide the City of Tulsa a \$550 travel stipend. WES will cover the costs of meals and hotel directly.

Thanks for your email and sorry for the delayed response – we had to double check these costs with the venue and event planner. I'll break down the costs below:

- The total cost of the food is \$498
 - \$209 for breakfast and lunch from the event space on Monday
 - \$80 for the SIIP small group dinner externally
 - \$209 for breakfast and lunch from the event space on Tuesday)
- The total cost of the hotel is around \$590 (\$295 per night + taxes)

In total, everything will be around \$1,088 for food and accommodations, although this doesn't include taxes. Please let me know if you have any additional questions.
