## Policy Statement

### Background Information

This budget amendment will appropriate \$200,000.00 unappropriated funds from fund balance within the General Fund (Fund 100) for the Managed Entities- Economic Development Department within the Other Service account group. The Council and Mayor approved resolution 20174 quality event designation for the 2022 PGA Championship identifying the Southern Hills Country Club as the event's certified sponsor. The quality event revenue received by the State for this event was \$250,000.00 which exceeds the available appropriations of \$200,000.00 currently budgeted for FY23 quality events. This budget action increases appropriations to fully pay Southern Hills and the estimated FY23 quality events still under review.

AN ORDINANCE AMENDING THE FISCAL YEAR 2022-23 BUDGET OF THE CITY OF TULSA, OKLAHOMA, BE AND IT IS HEREBY AMENDED TO MAKE SUPPLEMENTAL APPROPRIATIONS OF TWO HUNDRED THOUSAND DOLLARS (\$200,000.00) FROM UNAPPROPRIATED FUND BALANCE WITHIN THE GENERAL FUND (FUND 100), AS FOLLOWS:

BE IT ORDAINED BY THE CITY OF TULSA:

Section 1. That the Fiscal Year 2022-23 Budget of the City of Tulsa, Oklahoma, be and it is hereby amended to make supplemental appropriations of Two Hundred Thousand Dollars (\$200,000.00) from Unappropriated Fund Balance within the General Fund (Fund 100), as follows:
