AN ORDINANCE AMENDING THE FISCAL YEAR 2022-23 BUDGET OF THE CITY OF TULSA, OKLAHOMA, TO TRANSFER AVAILABLE APPROPRIATIONS OF THIRTY-FIVE THOUSAND DOLLARS AND ZERO CENTS (\$35,000.00) BETWEEN DEPARTMENTS WITHIN THE GENERAL FUND (FUND 100) AND SEVEN THOUSAND ONE HUNDRED AND NINETY-NINE DOLLARS AND ZERO CENTS (\$7,199.00) BETWEEN DEPARTMENTS, ACCOUNT GROUPS, AND PROJECTS WITHIN THE 2014 SALES TAX FUND (FUND 405), AS FOLLOWS:

BE IT ORDAINED BY THE CITY OF TULSA:

Section 1.
