Policy Statement

Background Information

"This action will transfer a total of \$99,997.00 between Departments and Accounts for the MAYOR'S OFFICE OF ECONOMIC DEVELOPMENT Department within the GENERAL FUND [FUND 100].

This transfer will move \$99,997 in available appropriations from the Tulsa Authority for Economic Opportunity's (TAE0) FY23 Budget, and place these funds within the budget of the Mayor's Office of Economic Development (MOED). These monies will be used to fund one (1) Small Business Enterprise Coordinator position within MOED.

This action will complete the intent outlined within the FY23 Management Service Agreement between the City of Tulsa and TAE0, amended in November of 2022. "

AN ORDINANCE AMENDING THE FISCAL YEAR 2022-23 BUDGET OF THE CITY OF TULSA, OKLAHOMA, TO TRANSFER AVAILABLE APPROPRIATIONS OF NINETY-NINE THOUSAND NINE HUNDRED NINETY-SEVEN DOLLARS AND NO CENTS (\$99,997.00) BETWEEN DEPARTMENTS AND ACCOUNT GROUPS WITHIN THE GENERAL FUND (FUND 100), AS FOLLOWS:

BE IT ORDAINED BY THE CITY OF TULSA:

Section 1. That the Fiscal Year 2022-23 Budget of the City of Tulsa, Oklahoma, be and it is hereby amended to transfer available appropriations of Ninety-Nine Thousand Nine Hundred Ninety-Seven Dollars and No Cents (\$99,997.00) between departments and account groups within the General Fund (Fund 100), as follows:
