### Policy Statement

**Background Information**

This budget amendment will appropriate \$244,898 from revenues received above original estimated revenues to comply with Tulsa City Council resolution #7571 passed in July 2008, to levy an annual special tax assessment which began July 1, 2009 within the Tulsa Stadium Improvement District Fund, Fund 141. Assessment revenue collected within Fund 141 are utilized for improvements and services, as well as, support enhancement and redevelopment of downtown property for economic benefit. As assessment revenues are received, they are split between two components, capital and services. District revenue support enhancements and redevelopment of downtown property to increase the economic benefit derived from the downtown infrastructure, Ballpark and BOK Center investments.

AN ORDINANCE AMENDING THE FISCAL YEAR 2022-23 BUDGET OF THE CITY OF TULSA, OKLAHOMA TO MAKE SUPPLEMENTAL APPROPRIATIONS OF TWO HUNDRED FORTY-FOUR THOUSAND EIGHT HUNDRED NINETY-EIGHT DOLLARS AND ZERO CENTS (\$244,898.00), RECOGNIZED FROM REVENUES RECEIVED WITHIN THE TULSA STADIUM IMPROVEMENT DISTRICT FUND (FUND 141) AS FOLLOWS:

BE IT ORDAINED BY THE CITY OF TULSA:

Section 1. That the Fiscal Year 2022-23 Budget of the City of Tulsa, Oklahoma, is hereby amended to make supplemental appropriations of Two Hundred Forty-Four Thousand Eight Hundred Ninety-Eight Dollars and Zero Cents (\$244,898.00), recognized from revenues received within the Tulsa Stadium Improvement District Fund (Fund 141) as follows:
