ORDINANCE NO. _____

AN ORDINANCE AMENDING TITLE 49, TULSA REVISED ORDINANCES (TRO), “ADMINISTRATIVE, PERMIT, AND LICENSE FEES” BY THE ADDITION OF NEW CHAPTER 15, TITLED “URBAN DESIGN PERMIT FEES”, REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH; PROVIDING SEVERABILITY; AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE CITY OF TULSA, OKLAHOMA:

Section 1. Title 49 TRO, “Administrative, Permit, and License Fees”, is hereby amended by the addition of new Chapter 15, titled “Urban Design Permit Fees” with shall recite in its entirety as follows:

“Chapter 15. Urban Design Permit Fees.

Section 1501- Urban Design Permit Fee Schedule.

The fees for Urban Design Permits are as follows:

- A. Initial Application fee for Tables & Chairs program, Sidewalk Café program, and Parklet program: \$150.00
- B. Renewal Application fee for Tables & Chairs program, Sidewalk Café program, and Parklet Program: \$100.00
- C. Resubmission or amendment fee for Tables & Chairs program, Sidewalk Café program, and Parklet program: \$86.00
- D. Metered parking space fee for Private Parklet (per space): \$1,175.00
- E. Metered parking space fee for Public Parklet (per space): \$585.00
- F. Reinspection fee (each additional inspection): \$58.00

Section 2. REPEAL OF CONFLICTING ORDINANCES. That all ordinances or parts of ordinances in conflict herewith be and the same are now expressly repealed.

Section 3. SEVERABILITY CLAUSE. If any section, sentence, clause or phrase of this ordinance or any part thereof is for any reason found to be invalid by a court of competent jurisdiction, such decision shall not affect the validity of the remainder of this ordinance or any part thereof.

Section 4. EMERGENCY CLAUSE. That an emergency is now declared to exist for the preservation of the public peace, health and safety, by reason whereof this ordinance shall take effect immediately from and after its passage, approval and publication.
