AN ORDINANCE AMENDING THE FISCAL YEAR 2023-24 BUDGET OF THE CITY OF TULSA, OKLAHOMA TO MAKE SUPPLEMENTAL APPROPRIATIONS OF ONE HUNDRED TWENTY THOUSAND DOLLARS AND NO CENTS (\$120,000.00), RECOGNIZED FROM UNAPPROPRIATED FUND BALANCE WITHIN THE ECONOMIC DEVELOPMENT COMMISSION FUND (FUND 130) AS FOLLOWS:

BE IT ORDAINED BY THE CITY OF TULSA:

Section 1.
