AN ORDINANCE AMENDING THE FISCAL YEAR 2023-24 BUDGET OF THE CITY OF TULSA, OKLAHOMA, TO MAKE SUPPLEMENTAL APPROPRIATIONS OF SEVENTY-TWO THOUSAND NINETEEN DOLLARS (\$72.019.00): FORTY-THREE THOUSAND TWO ELEVEN DOLLARS (\$43,211.00) FROM HUNDRED GRANT REVENUES TO BE RECEIVED FROM THE OKLAHOMA HISTORICAL SOCIETY AND A GRANT MATCH OF TWENTY-EIGHT THOUSAND EIGHT HUNDRED EIGHT DOLLARS (\$28,808.00) TRANSFER TO BE RECEIVED FROM THE GENERAL FUND (FUND 100) WITHIN THE HISTORIC PRESERVATION GRANT SUBFUND (SUBFUND 2300); AND TO TRANSFER UNENCUMBERED AND UNEXPENDED APPROPRIATION BALANCES OF TWENTY-EIGHT THOUSAND EIGHT HUNDRED EIGHT DOLLARS (\$28,808.00) BETWEEN DEPARTMENTS AND ACCOUNT GROUPS WITHIN THE GENERAL FUND (FUND 100), AS FOLLOWS:

#### BE IT ORDAINED BY THE CITY OF TULSA:

Section 1. That the Fiscal Year 2023-24 Budget of the City of Tulsa, Oklahoma, be and it is hereby amended to make supplemental appropriations of Seventy-Two Thousand Nineteen Dollars (\$72,019.00). Forty-Three Thousand Two Hundred Eleven Dollars (\$43,211.00) from grant revenues to be received from the Oklahoma Historical Society and a grant match of Twenty-Eight Thousand Eight Hundred Eight Dollars (\$28,808.00) transferred to be received from the General Fund (Fund 100) within the Historic Preservation Grant Subfund (Subfund 2300).
