The City of Tulsa has received a grant award from the Oklahoma Historical Society through the Certified Local Governments Program. This is a grant award that is managed by the Planning Office and is received every year. In the most recent past, this grant has been managed at INCOG, but with the transition of the Planning Office to the Department of City Experience, the grant is, once again, managed within the City. The grant total is \$72,019.00 of which \$43,211 is Federal reimbursement and \$28,808 is a local in-kind match. Match is met with the Historic Preservation Grant manager salary. Grant funds will be used to present at least one workshop on wood window repair, conduct a survey of the Maple Ridge Historic Residential District, and print and distribute postcards for Historic Preservation (HP) Zoning notifications. Funds for staff training are also included.

AN ORDINANCE AMENDING THE FISCAL YEAR 2023-24 BUDGET OF THE CITY OF TULSA, OKLAHOMA, TO MAKE SUPPLEMENTAL APPROPRIATIONS OF SEVENTY-TWO THOUSAND NINETEEN DOLLARS (\$72,019.00); FORTY-THREE THOUSAND TWO HUNDRED ELEVEN DOLLARS (\$43,211.00) FROM GRANT REVENUES TO BE RECEIVED FROM THE OKLAHOMA HISTORICAL SOCIETY AND A GRANT MATCH OF TWENTY-EIGHT THOUSAND EIGHT HUNDRED EIGHT DOLLARS (\$28,808.00) TRANSFER TO BE RECEIVED FROM THE GENERAL FUND (FUND 100) WITHIN THE HISTORIC PRESERVATION GRANT SUBFUND (SUBFUND 2300); AND TO TRANSFER UNENCUMBERED AND UNEXPENDED APPROPRIATION BALANCES OF TWENTY-EIGHT THOUSAND EIGHT HUNDRED EIGHT DOLLARS (\$28,808.00) BETWEEN DEPARTMENTS AND ACCOUNT GROUPS WITHIN THE GENERAL FUND (FUND 100), AS FOLLOWS:

BE IT ORDAINED BY THE CITY OF TULSA:

Section 1. That the Fiscal Year 2023-24 Budget of the City of Tulsa, Oklahoma, be and it is hereby amended to make supplemental appropriations of Seventy-Two Thousand Nineteen Dollars (\$72,019.00). Forty-Three Thousand Two Hundred Eleven Dollars (\$43,211.00) from grant revenues to be received from the Oklahoma Historical Society and a grant match of Twenty-Eight Thousand Eight Hundred Eight Dollars (\$28,808.00) transferred to be received from the General Fund (Fund 100) within the Historic Preservation Grant Subfund (Subfund 2300).
