AN ORDINANCE AMENDING THE FISCAL YEAR 2023-24 BUDGET OF THE CITY OF TULSA, OKLAHOMA, TO MAKE SUPPLEMENTAL APPROPRIATIONS OF SEVENTY THOUSAND FIVE HUNDRED NINETY-THREE DOLLARS AND NINETY CENTS (\$70,593.90) FROM ANIMAL WELFARE DONATIONS RECEIVED WITHIN THE SOCIAL ECO DEVELOPMENT NON-FED SUBFUND (SUBFUND 1705), AS FOLLOWS:

BE IT ORDAINED BY THE CITY OF TULSA:
