AN ORDINANCE AMENDING TITLE 33, TULSA REVISED ORDINANCES, "GENERAL PROVISIONS," SECTION 101, "DEFINITIONS AND RULES OF CONSTRUCTION"; SUBSECTION E ENTITLED "DELEGATION OF AUTHORITY"; REPEALING ALL ORDINANCES IN CONFLICT HEREWITH; AND PROVIDING SEVERABILITY.

BE IT ORDAINED BY THE CITY OF TULSA, OKLAHOMA:

Section 1. That Title 33, Tulsa Revised Ordinances, "General Provisions," Section 101, "Definitions and Rules of Construction," Subsection E entitled "Delegation of Authority," be and the same is hereby amended to recite as follows:

"E. Delegation of authority. Whenever any authority, duty or other activity is charged to a City department or division, or to a City officer or employee, it may be done as well by another department, division, officer, or employee designated by the Mayor, so long as not prohibited by ordinance, Charter or the laws or Constitution of the state."

Section 2. REPEAL OF CONFLICTING ORDINANCES. That all ordinances or parts of ordinances in conflict herewith be and the same are now expressly repealed.

Section 3. SEVERABILITY CLAUSE. If any section, subsection, paragraph, subparagraph, sentence, clause, or phrase of this Ordinance shall be declared invalid for any reason whatsoever, such decision shall not affect the remaining portions of this Ordinance, which shall remain in full force and effect, and to this end, the provisions of this Ordinance are hereby declared to be severable.
