Policy Statement

Background Information

This action will appropriate a total of \$500,000.00 to the PUBLIC WORKS DEPARTMENT within the NATIONAL INFRASTRUCTURE INVESTEMENTS SUB-FUND [SUB-FUND 2500].

MTTA received a Better Utilizing Investments to Leverage Development (BUILD) grant in the amount of \$6,500,000.00. Additionally, MTTA has been awarded a grant from the Federal Highway Administration (FHA) in the amount of \$500,000. This action will recognize the additional amount of \$500,000 to be received from the FHA Congestion Mitigation & Air Quality (CMAQ) grant received by MTTA. The City has a signed memorandum of understanding with MTTA to manage the funds for this project. The overall budget for this project is \$9,500,000 from the following sources:

AN ORDINANCE AMENDING THE FISCAL YEAR 2023-24 BUDGET OF THE CITY OF TULSA, OKLAHOMA, IS HEREBY AMENDED TO MAKE SUPPLEMENTAL APPROPRIATIONS OF FIVE HUNDRED THOUSAND DOLLARS AND ZERO CENTS (\$500,000.00) OF GRANT REVENUE TO BE RECEIVED FROM THE METROPOLITAN TULSA TRANSIT AUTHORITY TO BE RECEIVED WITHIN THE NATIONAL INFRASTRUCTURE INVESTMENTS SUB-FUND (SUB-FUND 2500) AS FOLLOWS:
