The Legislature is approaching its second major deadline for this session for bills to be approved by committees in the opposite chamber. The Board will be briefed on the status of the Coalition of Tulsa Area Local Governments legislative slate and other bills of importance to local governments.

5. Transportation

A. Approval of Transportation Alternative Program (TAP) Projects

INCOG recently solicited project applications from eligible local sponsors for projects utilizing the FFY2022-2024 Transportation Alternatives Program funding. INCOG received seventeen applications from eight jurisdictions totaling \$12.6 million in federal funding requests. The Transportation Technical Committee and the Transportation Policy Committee recommended nine projects for a total of \$6,299,596 in federal funds. A summary of the recommended projects is included in the agenda packet. The board is asked to approve the recommended projects.

B. Approval of Title VI Plan

The purpose of Title VI planning document is to ensure that the INCOG Transportation Planning Program complies with Title VI of the Civil Rights Act of 1964 and related statutes regarding nondiscrimination and environmental justice. The documented process ensures consideration of all individual input; ensures that the level and quality of transportation planning and products is provided equitably and without regard to race, color, national origin, disability or income; recognizes specific and prominent community issues and circumstances; identifies mechanisms for eliciting involvement from low-income, minority, and other residents and representatives as outlined in the Public Participation Plan; provides access to information for individuals and other interested parties; avoids, minimizes, or mitigates disproportionately high and adverse human health and environmental effects, including social and economic effects of transportation planning programs and activities on minority populations, persons with disabilities, and low-income populations;

ensures the full and fair participation of all affected populations to transportation planning programs and activities that affect minority populations, Limited English Proficiency (LEP) individuals, persons with disabilities, and low-income populations. The plan is attached as a pdf link. A current Title VI plan is a prerequisite for receiving federal transportation funds. The Board is asked to approve the Plan.
