AN ORDINANCE AMENDING THE FISCAL YEAR 2023-24 BUDGET OF THE CITY OF TULSA, OKLAHOMA, TO MAKE SUPPLEMENTAL APPROPRIATIONS OF SIX HUNDRED NINETY-TWO THOUSAND FIVE HUNDRED FOUR DOLLARS AND NINETY-TWO CENTS (\$692,504.92) FROM GRANT REVENUES RECEIVED FROM THE UNITED STATES TREASURY AMERICAN RESCUE PLAN ACT SUBFUND (SUBFUND 3001), AS FOLLOWS:

BE IT ORDAINED BY THE CITY OF TULSA:

Section 1. That the fiscal year 2023-24 budget of the City of Tulsa, Oklahoma, be and it is hereby amended to make supplemental appropriations of Six Hundred Ninety-Two Thousand Five Hundred Four Dollars and Ninety-Two Cents (\$692,504.92) from grant revenues received from the United States Treasury American Rescue Plan Act Sub Fund (Sub Fund 3001) as follows:
