## Background Information

This ordinance will appropriate \$49,800 in revenue to be received from Oklahoma State Bureau of Investigation (OSBI) within the Police Department Internet Crimes Against Children subfund. An agreement was reached between the Oklahoma State Bureau of Investigation (OSBI) and the Tulsa Police Department (TPD) for participation in a federal grant from the US Department of Justice, Office of Juvenile Justice and Delinquency Prevention (OJJDP). The OSBI shall pass through OJJDP funds to the TPD for the reimbursement of authorized expenses for the Cyber Crimes Unit. Fund will be used for equipment and training. CFDA #16.800. Grant #25203.

AN ORDINANCE AMENDING THE FISCAL YEAR 2023-24 BUDGET OF THE CITY OF TULSA, OKLAHOMA, TO MAKE SUPPLEMENTAL APPROPRIATIONS OF FORTY-NINE THOUSAND EIGHT HUNDRED DOLLARS AND ZERO CENTS (\$49,800.00) FROM GRANT REVENUES TO BE RECEIVED FROM THE US DEPARTMENT OF JUSTICE WITHIN THE INTERNET CRIMES AGAINST CHILDREN GRANTS SUBFUND (SUBFUND 2418), AS FOLLOWS:

BE IT ORDAINED BY THE CITY OF TULSA:
