A RESOLUTION OF THE CITY OF TULSA SUPPORTING THE PARTICIPATION OF EAST TULSA MAIN STREET, INC. IN THE 2024-2025 OKLAHOMA MAIN STREET CENTER WITH THE SPECIFIC GOAL OF REVITALIZING THE TULSA GLOBAL DISTRICT USING THE MAIN STREET 4-POINT APPROACH TO ECONOMIC DEVELOPMENT, AND DECLARING AN EMERGENCY.

**WHEREAS**, the Oklahoma Main Street Center was established in the Oklahoma Department of Commerce to assist small towns and cities to develop a public/private effort to revitalize their “Main Street” areas; and

**WHEREAS**, the East Tulsa Main Street program has been a vital component of the economic and historic restoration of the Tulsa Global District; and

**WHEREAS**, the East Tulsa Main Street program has helped to preserve and restore the rich architectural history of the Tulsa Global District; and

**WHEREAS**, the East Tulsa Main Street program has brought additional jobs to the Kendall Whittier community and spurred reinvestment in the area;

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF TULSA, OKLAHOMA:**

**Section 1.** That the City of Tulsa, Oklahoma, supports the participation of East Tulsa Main Street, Inc. in the 2024-2025 Oklahoma Main Street Center with the specific goal of revitalizing the Tulsa Global District using the Main Street 4-Point Approach to economic development.

**Section 2.** That the City of Tulsa, Oklahoma, understands that the Main Street Approach is a long-term process that results in a continual effort to maintain and enhance the Main Street district.
