Haikey Creek Quarterly Report Cindy Cantero City of Tulsa Water & Sewer Department A summary of Haikey Creek Wastewater Treatment Plant performance; status of design and construction projects; discussion of planning issues impacting the RMUA facilities; and the current flow split between the City of Tulsa and the City of Broken Arrow.

## \*6. MISC. ACTION ITEMS

- a. Riverbend Meadows Sanitary Sewer Service Megan Pasco and Justin P. Morgan from Tanner Consulting As the proposed residential subdivision, Riverbend Meadows, is in the Broken Arrow fenceline, Tanner Consulting requests that the development be allowed to dispose of wastewater directly into the Haikey Creek WWTP via a new lift station and force main, inlieu of pumping to an existing Broken Arrow lift station 2 miles north of the site. The proposed lift station could be designed with expansion in mind to serve as a future regional station for approximately 2,400 acres of land within the Broken Arrow fenceline.
- b. Ordinance Budget Amendment Haikey Creek WWTP Biosolids Improvements (Fund 951) Jhoanna Murray. This budget action will appropriate \$642,068 to the Haikey Creek WWTP Biosolids Improvement Project within the RMUA Capital Projects fund. The scope of the project includes completing the NEPA Environmental assessment and cultural survey and provide design services related to (1) new blower building, (2) rehab of the west sludge tank, (3) yard piping RDTs to holding tanks, (4) removal of old piping and valves for sludge and scum tanks, (5) new office building, and (6) gravity thickener decommissioning. Amendment No. 2 will also include pilot studies for dewatering and composting. The original contract in the amount of \$499,935.59, Amendment No. 1 in the amount of \$3,705,899.00, and Amendment No. 2 in the amount of \$642,068.00 increased the total contract to \$4,847,882.59. Split 50/50 with Broken Arrow TMUA portion: \$321,034.00 Broken Arrow portion: \$321,034.00 = Total: \$642,068.00 RECOMMEND APPROVAL
- c. New Contract Contract No. 139247 RMUA Property Insurance Arthur J. Gallagher Rick Management Cindy Cantero. The RMUA Insurance Broker, Arthur J. Gallagher, solicited RMUA facility insurance for the policy period 10/1/2024-10/1/2025. Coverage will be provided by Oklahoma Municipal Assurance Group with a quoted premium of \$170,557.00 and provides catastrophic damages to RMUA facilities as a result of fire, wind or hail, lightning, etc. The Property Insurance Proposal and quote will need to be bound in order to secure coverage for

the policy period. Submitted for your signature and approval is a Property Insurance Policy for RMUA properties. Binding coverage informs the insurer of the RMUA's acceptance of the policy quote and terms. **RECOMMEND APPROVAL** (Contract No. 139247) (Tracking No. UB0120894)

d. Amendment No. 1 – Contract No. 137592 – Insurance Broker Services – Arthur J Gallagher Rick Management – Cindy Cantero. Submitted is Amendment #1 to the Agreement for Insurance Broker Services between the Regional Metropolitan Utility Authority and Arthur J. Gallagher Risk Management Services, Inc. in the amount of \$15,000.00. The scope of the project includes broker services needed to renew an annual catastrophic property insurance policy for the sole coverage of RMUA assets. The original agreement in the amount of \$27,950.00 and Amendment No. 1 in the amount of \$15,000 increases the total contract amount to \$42,950.00. RECOMMEND APPROVAL (Contract No. 137592)
