- 1. Call the combined special meeting of the Trustees of the Tulsa Airports Improvement Trust ("TAIT") and regular meeting of the Members of the Tulsa Airport Authority ("TAA") to order.
- 2. Approve the minutes of the July 10, 2025, combined meetings of TAIT and TAA.
- 3. Operating Report, Financial Report.
- 4. Motion to temporarily suspend the By-laws of the Tulsa Airports Improvement Trust related specifically to the election of officers for the purpose of electing officers protempore.

Section 3.3 of the By-laws of the Tulsa Airports Improvement Trust state that "In the absence or disability of the chairman, the vice chairman shall have all of the duties and powers of the chairman." Section 4.1 provides that elections are to be held at the Annual Meeting, which is scheduled for September 11, 2025.

There are no provisions in the bylaws addressing the absence or incapacity of both the Chair and the Vice-Chair. The election of officers pro-tempore will ensure continuity of leadership and decision-making.

5. Nomination and election of TAIT Chair and Vice Chair on a Pro-Tempore basis.

The officers elected today will serve a temporary term until the Annual Meeting on September 11, 2025, and at such time the Trustees can comply with Section 4.1 of the bylaws.

Administrative, Finance, IT, and Operations Contract Action.

6. Approve revision to TAIT's Schedules of Rates, Fees, and Charges effective September 1, 2025 to add a charge of \$0.35 per KWH for the use of the parking garage EV chargers. This charge will cover operational costs.

- 7. Approve purchase of a Lone Star ProMaster 3500 shuttle bus from Creative Bus Sales, Inc., in an amount not to exceed \$125,271.00. TUL. Oklahoma State Contract SW0797C.
- 8. Approve Right of Entry to the Federal Aviation Administration ("FAA") for the construction of a new Air Traffic Control Tower at Tulsa Riverside Airport.
- 9. Rescind approval of Agenda Item 15 from the June 12, 2025 meeting of TAIT which accepted and approved a pending Oklahoma Department of Aerospace and Aeronautics ("ODAA") Grant in an amount up to \$4,780.00, for the RVS Drainage Improvements Project.

Engineering Capital Improvement Contract Action.

Contracts.

10. Accept bid and approve award of contract to United Ford South, LLC dba Bill Knight Ford, in the amount of \$889,213.00 for the purchase of 15 electric vehicles for the Vehicle Electrification Project, TUL Contract F26-012.

This contract provides funding to purchase 13 electric vehicles ("EVs") for Airport maintenance and operations and two EVs to be used as motor pool cars. TAIT received one bid, the estimate was \$946,000.00, 6.4% above the lowest responsible bidder. The Disadvantaged Business Enterprise ("DBE") goal was 0.0% and the contractor has committed to utilizing 0.0%.

11. Accept bid and approve award of contract to L&M Office Furniture, LLC, in the amount of \$491,816.57 for the purchase of furniture for Tulsa International Airport GAF-FIS Facility Project, TUL Contract F26-015.

This contract provides funding to purchase and install furniture to be used in the new GAF-FIS facility. TAIT received two bids; one bid was non-responsive. The budget amount is \$951,000.00, 51% above the lowest responsible bidder.

12. Approve award of Professional Services Agreement with Frankfurt-Short-Bruza Associates, P.C., in an amount not to exceed \$147,884.00 for the Data Center Project. TUL Contract F26-013.

This contract provides funding to perform design services to upgrade our existing server room to current standards.

13. Approve Amendment Number One to Agreement for Professional Services to TranSystems Corporation of Oklahoma, in an amount not to exceed \$29,000.00 for the Consolidated Rent-A-Car (CONRAC) Facility Development Study Project. TUL Contract F25-072.

This amendment adds additional scope of work for the structural evaluation of the existing garage to verify the possibility of adding a third and fourth level to the west portion of the garage.

This amendment adds additional scope of work for the development of the Construction Safety and Phasing Plan (CSPP) to the plan set.
