Resolution calling for, and requesting the Election Board to conduct, a non-partisan Special Election on February 10, 2026, for the purpose of submitting to the Qualified Voters of the City Of Tulsa, in accordance with Oklahoma Statutes Title 68, §§ 2701 and 2705, the question of whether City of Tulsa Ordinance, increasing the levy of an excise tax upon the gross proceeds or gross receipts derived from the rent from every occupancy of a room or rooms in a hotel in this City from five percent (5%) to nine and one-quarter percent (9.25%), shall be approved; giving notice to the Tulsa, Osage, Rogers, and Wagoner County Election Boards of said election, pursuant to Oklahoma Statutes Title 26, § 3-101 and § 13-102, and amendments thereto; authorizing and requesting the Mayor of the City of Tulsa to call and proclaim the holding of the Special Election in the City of Tulsa in accordance with Article VI of the City Charter, Section 4 "Calling Elections". **(Emergency Clause)** [BUD/SP 11/12/25; CC 11/19/25] 25-975-1

4. Ordinance (“Seven-Tenths of a Penny Sales Tax”) amending the Sales Tax Ordinance of the City of Tulsa, Oklahoma, Title 43, of the Tulsa Revised Ordinances, by amending Title 43, Chapter 1, Section 100, of the Tulsa Revised Ordinances to permanently increase the levy of an excise tax, to be used for general purposes of municipal government, upon the gross proceeds or gross receipts derived from all sales taxable under the Sales Tax Code of Oklahoma, and upon the sale of natural or artificial gas and electricity when sold exclusively for residential use, from two percent (2%) to two and seven-tenths percent (2.7%), to be effective as of July 1, 2026; providing that if, at the February 10, 2026 election, the voters of the City of Tulsa do not approve this sales tax increase, then this ordinance shall be null and void and of no further effect; repealing all ordinances or parts of ordinances in conflict herewith; providing for severability. **(Emergency Clause)** [BUD/SP 11/12/25; CC 11/12/25; CC 11/19/25] 25-976-1

Resolution calling for, and requesting the Election Board to conduct, a non-partisan Special Election on February 10, 2026, for the purpose of submitting to the Qualified Voters of the City of Tulsa, in accordance with Oklahoma Statutes Title 68, §§ 2701 and 2705, the question of the “Seven-Tenths of a Penny Sales Tax”, City of Tulsa Ordinance, which permanently increases the levy of an excise tax, also known as a sales tax, to be used for general purposes of municipal government from two percent (2%) to two and seven-tenths percent (2.7%), commencing on July 1, 2026; providing that this tax shall be in addition to any other sales tax then existing; stating the purposes of the said tax; giving notice to the Tulsa, Osage, Rogers, and Wagoner County Election Boards of said election, pursuant to Title 26 Oklahoma Statutes § 3-101 and § 13-102, and amendments thereto; authorizing and requesting the Mayor of the City of Tulsa to call and proclaim the holding of the Special Election in the City of Tulsa in accordance with Article VI of the City Charter, Section 4 “Calling Elections”. **(Emergency Clause)** [BUD/SP 11/12/25; CC 11/19/25] 25-977-1
