
SECOND AMENDMENT TO





Bike racks will be located in the 11ftx7ft vacant rectangle to the east of the manhole cover.

Property Description: Across from Dollar General and next to Osage Prairie Trail, Dead End of N. Midland Place, near Pine, but not connected to Pine as it is a dead end. Occupying asphalt at the end of the street, 40+ east of the manhole cover and not to impede access to the manhole, assets anchored to asphalt.
