**Background Information**

The City of Tulsa Received \$87,826,517.00 in American Rescue Plan Act (ARPA) funds to be used as specified in the US Department of the Treasury's Final Rule and accompanying information in the Compliance Reporting Guidance. This Budget action will appropriate \$4,600,000.00 of ARPA unappropriated fund balance to fund this project.

Funding will provide a safe and stable environment with services to help formerly homeless individuals and families who have no other housing options to achieve personal objectives and transition into permanent housing within 120 days. Will work in partnership with other local agencies for a comprehensive strategy to meet Path To Home goals. Project approved by the City of Tulsa Board of Adjustment 9/10/24.

AN ORDINANCE AMENDING THE FISCAL YEAR 2024-25 BUDGET OF THE CITY OF TULSA, OKLAHOMA, IS HEREBY AMENDED TO MAKE SUPPLEMENTAL APPROPRIATIONS OF FOUR MILLION SIX HUNDRED THOUSAND DOLLARS AND ZERO CENTS (\$4,600,000.00) FROM GRANT REVENUES RECEIVED FROM THE UNITED STATES TREASURY AMERICAN RESCUE PLAN ACT SUBFUND (SUBFUND 3001), AS FOLLOWS:

BE IT ORDAINED BY THE CITY OF TULSA:

Section 1. That the fiscal year 2024-25 budget of the City of Tulsa, Oklahoma, is hereby amended to make supplemental appropriations of Four Million Six Hundred Thousand Dollars and Zero Cents (\$4,600,000.00) from grant revenues received from the United States Treasury American Rescue Plan Act Sub Fund (Sub Fund 3001) as follows:
