AN ORDINANCE AMENDING THE FISCAL YEAR 2024-25 BUDGET OF THE CITY OF TULSA, OKLAHOMA, TO MAKE SUPPLEMENTAL APPROPRIATIONS OF TWENTY THOUSAND DOLLARS AND ZERO CENTS (\$20,000.00), FROM GRANT REVENUES TO BE RECEIVED FROM THE ARVEST FOUNDATION, WITHIN THE SOCIAL ECO DEVELOPMENT NON-FED GRANT PROGRAMS SUBFUND (SUBFUND 1705), AS FOLLOWS:
