**Background Information**  
This action will appropriate a total of \$500,000.00, recognized from Unappropriated Fund Balance, appropriating to the DEPARTMENT OF CITY EXPERIENCE within the 2020 SALES TAX FUND [FUND 409].

This Budget Amendment will appropriate \$500,000.00 from fund balance within the 2020 Sales Tax Fund (Fund 409) to provide funding toward the architectural/engineering design costs, purchase of construction materials, and construction costs of the Bazar Grocery Store, a fully-automated grocery store that will provide fresh food to the community. Additional funding for this project is provided by the project owner, Tulsa Metropolitan Ministries, Food on the Move, Inheritance Juicery, Cherokee Nation, and various local farmers.

Funds have been held to allow for City Council review and approval of projects proposed for funding from the Council District Priority Project allocation. The City Council and Mayor have now approved the project from the City Council District 3 portion of the City Council District Priority Project.

AN ORDINANCE AMENDING THE FISCAL YEAR 2024-25 BUDGET OF THE CITY OF TULSA, OKLAHOMA, BE AND IT IS HEREBY AMENDED TO MAKE SUPPLEMENTAL APPROPRIATIONS OF FIVE HUNDRED THOUSAND DOLLARS AND ZERO CENTS (\$500,000.00), RECOGNIZED FROM UNAPPROPRIATED FUND BALANCE WITHIN THE 2020 SALES TAX FUND (FUND 409) AS FOLLOWS:

BE IT ORDAINED BY THE CITY OF TULSA:

Section 1. That the Fiscal Year 2024-25 Budget of the City of Tulsa, Oklahoma, be and is hereby amended to make supplemental appropriations of Five Hundred Thousand Dollars and Zero Cents (\$500,000.00), recognized from Unappropriated Fund Balance within the 2020 Sales Tax Fund (Fund 409), as follows:
