Background Information

This action will appropriate a total of \$50,000.00, recognized from Unappropriated Fund Balance, appropriating to the DEPARTMENT OF CITY EXPERIENCE within the 2020 SALES TAX FUND [FUND 409].

This Budget Amendment will appropriate \$50,000.00 from fund balance within the 2020 Sales Tax Fund (Fund 409) to provide funding towards the improvement of Kendall Whittier Main Street. These improvements consist of beautification, placemaking, and art projects including Whittier Square Clock repairs; Route 66 Neon sign and neon light enhancement to Whittier Square; district wayfinding signage; district and seasonal street light banners; two pieces of public art to serve as district gateways; 8-10 utility box art installations; and public art at the Kendall Whittier Library. This project has an additional \$210,000.00 in funding from private donations and a state grant, bringing the total project funding to \$260,000.00.

Funds have been held to allow for City Council review and approval of projects proposed for funding from the Council District Priority Project allocation. The City Council and Mayor have now approved the project from the City Council District 4 portion of the City Council District Priority Project.
