AN ORDINANCE TO ADOPT A REVISION AND GENERAL CODE OF ORDINANCES FOR THE CITY OF TULSA, OKLAHOMA, TO BE KNOWN AS THE "TULSA REVISED ORDINANCES," INCLUDING ORDINANCES DEFINING OFFENSES AND PRESCRIBING PENALTIES FOR THE VIOLATION OF THE SAME; REPEALING ALL OTHER ORDINANCES EXCEPT CERTAIN ORDINANCES HEREIN EXCEPTED; PROVIDING THE EFFECTIVE DATE OF THE TULSA REVISED ORDINANCES; SAVING ALL PENDING PROCEEDINGS AND EXISTING RIGHTS AND REMEDIES; AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE CITY OF TULSA:

#### SECTION 1. ADOPTION OF REVISED ORDINANCES

The revised ordinances, three copies of which are now on file in the office of the City Clerk prepared by Municipal Code Corporation and the City Legal Department pursuant to the direction and by authority of the governing body of the City of Tulsa, Oklahoma, be and the same are hereby adopted as the Revised Ordinances of the City of Tulsa, Oklahoma, and to be known as the "Tulsa Revised Ordinances," effective as of the date hereinafter specified.

#### SECTION 2. EXCEPTIONS

Ordinance No. 25331, enacted June 5, 2024, and all ordinances enacted subsequent thereto, are not included in the above volume as of this date, and it is hereby provided that all such ordinances shall continue in full force and effect from and after this date until hereafter repealed.

#### SECTION 3. REPEAL

All ordinances or parts of ordinances in effect as of the date of the passage of this ordinance and which are not contained in the volume of the Tulsa Revised Ordinances above described or which are not herein expressly stated to be continued in full force and effect be and the same are hereby repealed, effective concurrently with and as of the effective date of the Tulsa Revised Ordinances, above described.

#### SECTION 4. SAVING CLAUSE

Neither the repeal of any of said ordinances nor any of the provisions herein contained shall be deemed or constructed to impair, modify, alter, or affect any rights, right of action or cause of action, whether now pending in any court or not, which are now existing or which may

arise or come into existence, before the date when said Tulsa Revised Ordinances, above described, shall take effect.

SECTION 5. EFFECTIVE DATE OF TULSA REVISED ORDINANCES

The “Tulsa Revised Ordinances” are deemed to be in effect and in full force and operation as of twelve o’clock noon on January 1, 2025.

SECTION 6. EMERGENCY CLAUSE

That the amendments hereby enacted are essential to the proper, orderly and ethical conduct of the business of the City of Tulsa by its City Official; therefore, an emergency is hereby declared to exist for the preservation of the public peace, health, and safety, by reason whereof this ordinance shall take effect immediately upon its passage, approval, and publication.


