A RESOLUTION OF THE CITY OF TULSA, OKLAHOMA,  
SUPPORTING THE 2022 ONEVOICE REGIONAL  
LEGISLATIVE AGENDA, ; URGING STATE AND FEDERAL  
LEGISLATORS TO CONSIDER THE ISSUES IDENTIFIED IN  
THE ONEVOICE AGENDA; AND DECLARING AN  
EMERGENCY.

**WHEREAS**, OneVoice is a regional advocacy effort led by the Tulsa Regional Chamber of Commerce, including seventy-five (75) chambers of commerce, municipalities, counties and economic development organizations; and

**WHEREAS**, OneVoice identifies and prioritizes key issues to be shared with state legislators, United States Senators and members of the United States House of Representatives via the Regional OneVoice Legislative Agenda, announced before the legislative session begins each year; and

**WHEREAS**, since 2007, the OneVoice Agenda has been the primary advocacy tool utilized by the Tulsa Regional Chamber of Commerce and its partners to communicate top-priority issues to its state legislators, United States Senators and members of the United States House of Representatives; and

**WHEREAS**, the 2021Regional OneVoice Legislative Agenda is incorporated into this resolution by reference, as published February 9, 2022, online at:
