

Policy Statement**Background Information**

This Ordinance will reduce appropriations within the Police Department's PD Equitable Sharing Treasury subfund (#2423).

In Nov 2019, the Property Room completed a check request for the US Marshal's for the sum of \$60,715. The check request was made prematurely but that was not discovered until after the check was deposited. In response to the error, the U.S. Treasury sent a "refund" check to the city for \$60,715. The U.S. Treasury check was deposited into the Chief's Forfeiture Fund, presumably because it was thought to be a forfeiture award, but it should have been deposited into fund 614 to await final resolution of the case to which it was tied.

Currently, the Final Order of Forfeiture has been officially completed for the case and funds are to be split between the U.S. Marshal and the District Atty revolving fund. Cash will be transferred from the Chief's Forfeiture Fund for the Police Property Room Fund to complete the required payment and appropriations in the Chief's Forfeiture Fund will be reduced by \$60,715.

AN ORDINANCE AMENDING THE FISCAL YEAR 2021-22 BUDGET OF THE CITY OF TULSA, OKLAHOMA, TO REDUCE APPROPRIATIONS OF SIXTY THOUSAND SEVEN HUNDRED FIFTEEN DOLLARS (\$60,715.00) WITHIN THE PD EQUITABLE SHARING TREASURY SUBFUND (SUBFUND NO. 2423), AS FOLLOWS:

BE IT ORDAINED BY THE CITY OF TULSA:

Section 1. That the Fiscal Year 2021-22 Budget of the City of Tulsa, Oklahoma, be and it is hereby amended to reduce appropriations of Sixty Thousand Seven Hundred Fifteen Dollars (\$60,715.00) within the PD Equitable Sharing Treasury Subfund (Subfund No. 2423), as follows:
