

Budget amendment ordinance making supplemental appropriations of \$850,000 from grant revenues to be received from the U.S. Department of Justice totaling \$750,000 and a transfer from the General Fund, Fund No. 1080, totaling \$100,000 within the cops Grant Award Fund, Fund No. 5317, to fund the salaries and benefits of six newly hired, full time sworn police officer positions for three years. 7. ORDINANCES - SECOND READING

Ordinance amending Tulsa Revised Ordinances, Title 43, "city of Tulsa Sales Tax code", the Sales Tax Ordinance of the city of Tulsa, Oklahoma; enacting a new Section 100, "Sales Tax Levied", setting an extended temporary sales tax levy of 1.167% in addition to the current permanent 2% sales tax, for the period of time beginning July 1, 2014 and continuing until the full amount of \$563,700,000 has been collected, but in no event continuing beyond 7 years, at which time the said sales tax shall be reduced from 3.167% to the said permanent 2%; providing notice to the Oklahoma Tax Commission when such amount has been reached and said sales tax can be so reduced; enacting a new Section 118, "Purposes of Revenue", declaring the purpose of this sales tax to be providing revenue for the support of the functions of municipal government of the City of Tulsa, and all revenue from the said sales tax in excess of the permanent 2% shall be expended on capital improvements as listed in detail in Title 43-H of Tulsa Revised Ordinances, "2014 Sales Tax Policy"; repealing Section 120, "Termination Date"; providing that if on November 12, 2013 the voters of the city of Tulsa do not pass and approve said sales tax, the amendments stated herein shall be null and void and of no further effect; providing for a severability cause. (Emergency Clause) [CIP 8/15/13] 13-643-2

- b. Ordinance creating a new Title 43-H, Tulsa Revised Ordinances, establishing the official policy of the City of Tulsa, Oklahoma, with regard to the expenditure of all monies received from extending the temporary sales tax levy of 1.167% for the period of time beginning July 1, 2014, and continuing until the full amount of \$563,700,000 has been collected, but in no event continuing beyond 7 years, which will be voted upon November 12, 2013 (The "2014 Extended 1.167% Sales Tax"); listing projects and purposed which will be accomplished from said revenues; creating the 2014 extended 1.167% Sales Tax Overview Committee and appointing members thereof; specifying powers and duties of said committee and officers and employees of the City of Tulsa, Oklahoma; establishing a special revenue fund known as the 2014 Extended 1.167% Sales Tax Fund, wherein all revenues received from said temporary sales tax levy, together with interest earned thereon, shall be deposited; prohibiting the expenditure of any of said funds for any purpose other than the projects and purposes set forth herein; prescribing certain mandatory duties of the Secretary of the Council and the Council of said city; providing the public notice and hearings upon any proposal to amend or repeal the ordinance. (Emergency Clause) [CIP 8/15/13] 13-645-2

Resolution giving notice of a special election on November 12, 2013, for the purpose of submitting to the qualified voters of the City of Tulsa, the question of the issuance of the bonds of said City in the sum of \$355,000,000 to be issued in series to provide funds (either with or without State of Federal Aid) for the purpose of constructing, reconstructing, improving, and repairing streets and bridges; and levying and collecting an annual tax, in addition to all other taxes, upon all taxable property in said city for the payment of the interest on and principal of said bends; listing specific projects, with a further listing of the dollar amounts to be expended on each project. (Emergency Clause) [CIP 8/15/13] 13-646-1
