Background Information
 This ordinance will appropriate \$38,220.00, recognized revenue to be received through a District Attorney's Council grant award, awarded to the Tulsa Police Department within the Victims of Crime Act (VOCA) subfund (Fund No. 2414). The purpose of the VOCA grant is to provide direct services to crime victims, including emotional and physical support, stabilization assistance, guidance through the criminal justice system, and enhanced safety. The grant will fund forensic medical examinations for sexual assault, domestic violence, child sexual assault, and strangulation cases, and will support the development of similar programs statewide. AN ORDINANCE AMENDING THE FISCAL YEAR 2025-26 BUDGET OF THE CITY OF TULSA, OKLAHOMA, TO MAKE SUPPLEMENTAL APPROPRIATIONS OF THIRTY-EIGHT THOUSAND TWO HUNDRED TWENTY DOLLARS AND ZERO CENTS (\$38,220.00) RECOGNIZED FROM GRANT REVENUES TO BE RECEIVED FROM DISTRICT ATTORNEY’S COUNCIL WITHIN THE VICTIMS OF CRIME ACT SUB-FUND (SUB-FUND 2414), AS FOLLOWS:

BE IT ORDAINED BY THE CITY OF TULSA:

Section 1.
