Policy Statement

Background Information

This Resolution creates the Kendall Whittier Improvement District consisting of certain parcels of real property located along the Lewis Avenue corridor between East Archer Street and East 6th Street South and along East Admiral Boulevard between Yorktown Avenue and Birmingham Avenue. The purpose of the District is to provide improvements and services set forth in 11 O.S. Sections 39-103 and 39-103.1. The Tulsa Planning Office (TPO) has conducted outreach and engaged property owners and other stakeholders. TPO has received a petition with signatures indicating that the owners of 62% of the parcels within the proposed district approve of the proposed district. Notice of a Public Hearing on April 20, 2022 before the City Council will be published pursuant to the Oklahoma Improvement District Act 11 O.S. Section 39-101 et seq. and mailed to the property owners within the proposed District in accordance with Oklahoma law.

RESOLUTION CREATING KENDALL WHITTIER IMPROVEMENT DISTRICT NO. 1 WITHIN GEOGRAPHICAL LIMITS OF THE CITY OF TULSA, CONSISTING OF CERTAIN PARCELS OF PROPERTY GENERALLY LOCATED ALONG THE LEWIS AVENUE CORRIDOR BETWEEN EAST ARCHER STREET AND EAST 6TH STREET SOUTH AND ALONG EAST ADMIRAL BOULEVARD BETWEEN YORKTOWN AVENUE AND BIRMINGHAM AVENUE FOR THE PURPOSE OF PROVIDING IMPROVEMENTS SERVICES SET FORTH IN 11 O.S. SECTION 39-103 AND 39-103.1(A); DIRECTING THE PREPARATION OF AN ASSESSMENT ROLL; AND DECLARING AN EMERGENCY.

WHEREAS, pursuant to Resolution No. <u>20173</u>, an assessment plat, a schedule showing the estimated maximum benefit for each parcel and stating the equitable basis for determining such benefit have been prepared and filed with the City and received by the City Council of the City of Tulsa; and

WHEREAS, the City Council of the City of Tulsa on April 20, 2022 held a public hearing on the proposed creation of the Kendall Whittier Improvement District No. 1 (the "District") after notice of said public hearing was mailed and published as provided by law.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF TULSA:

Section 1. That Kendall Whittier Improvement District No. 1 is hereby created and have shall exist until the 30th day of June 2027 provided that Kendall Whittier Improvement District No. 1 may be terminated as set forth in 11 O.S. Section 39-103.1(F).

<u>Section 2</u>. That the boundaries of the proposed Kendall Whittier Improvement District No. 1 are depicted on attached <u>Exhibit A</u> and a list of each property to be included within the District is attached as <u>Exhibit B</u>.

<u>Section 3.</u> That pursuant to 11 O.S. Section 39-103.1(A), Kendall Whittier Improvement District No. 1 is created for the purpose of providing or causing to be provided any maintenance, cleaning, security, upkeep, marketing, management or other services which confer special benefits upon property within the District. Services to be provided within the District include, and are generally described, as follows:

- Administration and management of the district services and improvements
- · Maintenance of landscaping throughout the district
- Trash removal throughout the district
- · Security services throughout the district
- · Signage to promote the district
- Capital maintenance of the public parking facility located at the Southeast Corner of South Lewis Avenue and East Admiral Boulevard
- Capital improvements throughout the district such as: the improvement or maintenance of street lighting and street lighting systems and the improvement of any street, parking, other facility by landscaping or planting of trees, shrubs, and other plant materials.

<u>Section 4.</u> That the proposed method of assessment levied against each property within Kendall Whittier Improvement District No. 1 shall be determined on the following equitable basis:

<u>Section 5.</u> That City staff shall prepare and file with the City Clerk an assessment roll containing the information required by 11 O.S. Section 39-110.

<u>Section 6</u>. That following the filing of the documents set forth in Section 5, the City Clerk is hereby directed to mail and publish notice of a public hearing as provided by 11 O.S. Section 39-110.

<u>Section 7</u>. An emergency is hereby declared to exist for the preservation of the public peace, health and safety, by reason whereof this Resolution shall take effect immediately upon its adoption, approval and publication.
