RESOLUTION \_\_\_\_\_

A RESOLUTION NOTIFYING THE PUBLIC OF THE PUBLICATION OF THE SECOND SUPPLEMENT TO THE EIGHTH REVISION OF THE TULSA REVISED ORDINANCES ADOPTED BY THE GOVERNING BODY OF THE CITY OF TULSA, OKLAHOMA, ON JANUARY 14, 2026, AUTHORIZING THE FILING OF THIS RESOLUTION IN THE OFFICES OF THE COUNTY CLERKS OF TULSA, OSAGE, ROGERS AND WAGONER COUNTIES, STATE OF OKLAHOMA; AUTHORIZING THAT THE SECOND SUPPLEMENT BE DEPOSITED IN THE COUNTY LAW LIBRARIES OF TULSA, OSAGE, ROGERS, AND WAGONER COUNTIES, STATE OF OKLAHOMA; DIRECTING THE SECOND SUPPLEMENT BE AVAILABLE FOR PURCHASE BY THE PUBLIC AT A REASONABLE PRICE; AND DECLARING AN EMERGENCY.

WHEREAS, the Eighth Revision of the Tulsa Revised Ordinances, including the penal ordinances of the City of Tulsa, was adopted by the governing body of the City of Tulsa on March 26, 2025, by Ordinance No. 25554, which established the effective date of the Eighth Revision of the Tulsa Revised Ordinances as January 1, 2025; and

WHEREAS, Ordinance No. 25554 was published in the Tulsa World on April 6, 2025; and

WHEREAS, the First Supplement, dated November 1, 2024, to the Eighth Revision of the Tulsa Revised Ordinances were passed and approved by the City Council on June 11, 2025, and approved by the Mayor on June 18, 2025, by Ordinance No. 25598, which was published on June 22, 2025; and

WHEREAS, the Second Supplement, dated July 1, 2025, to the Eighth Revision of the Tulsa Revised Ordinances were passed and approved by the City Council on January 14, 2026, and approved by the Mayor on January 21, 2025, by Ordinance No. 25725, which was published on January 25, 2026; and

WHEREAS, 11 O.S. 2001, §14-110, requires that the municipal governing body adopt a resolution notifying the public of the compilation and publication of the permanent volume or biennial supplement of penal ordinances of the municipality; that such resolution shall be filed in the offices of the county clerks of the counties in which the municipality is located; and that copies of the permanent volume and each biennial supplement shall be deposited in the county law libraries of the counties wherein the municipality is located;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF TULSA, OKLAHOMA:

Section 1. That the public is hereby notified that the Second Supplement, dated July 1, 2025, to the Eighth Revision of the Tulsa Revised Ordinances have been has been compiled and published and is in full force and effect;

Section 2. That a copy of this resolution shall be filed in the offices of the county clerks in Tulsa, Osage, Rogers and Wagoner Counties, state of Oklahoma;

Section 3. That a copy of the Second Supplement to the Eighth Revision of the Tulsa Revised Ordinances shall be deposited in the county law libraries of Tulsa, Osage, Rogers, and Wagoner Counties, state of Oklahoma;

Section 4. That a copy of the Second Supplement to the Eighth Revision of the Tulsa Revised Ordinances shall be available for purchase by the public at a reasonable price in the office of the City Clerk, Tulsa, Oklahoma;

Section 5. That an emergency exists for the preservation of the public health, safety and welfare, by reason whereof this resolution shall take effect immediately upon its adoption and approval.


