ORDINANCE NO.

AN ORDINANCE AMENDING THE FISCAL YEAR 2021-22 BUDGET OF THE CITY OF TULSA, OKLAHOMA, IS HEREBY AMENDED TO TRANSFER UNENCUMBERED AND UNEXPENDED APPROPRIATION BALANCES OF ONE HUNDRED EIGHTY-FOUR THOUSAND. NINE HUNDRED TWENTY DOLLARS AND THIRTY-THREE CENTS (\$184,920.33) BETWEEN PROJECTS AND ACCOUNTS WITHIN THE EMERGENCY RENTAL ASSISTANCE PROGRAM (ERAP) FUND (SUB FUND 3000), AS FOLLOWS:

BE IT ORDAINED BY THE CITY OF TULSA:

Section 1. That the Fiscal Year 2021-22 Budget of the City of Tulsa, Oklahoma, is hereby amended to transfer unencumbered and unexpended appropriation balances of One Hundred Eighty-Four Thousand, Nine Hundred Twenty Dollars and Thirty-Three Cents (\$184,920.33) between accounts within the Emergency Rental Assistance Program (ERAP) Fund (Sub Fund 3000), as follows:
