AN ORDINANCE AMENDING THE FISCAL YEAR 2022-23 BUDGET OF THE CITY OF TULSA, OKLAHOMA, BE AND IT IS HEREBY AMENDED TO TRANSFER UNENCUMBERED AND UNEXPENDED APPROPRIATION BALANCES OF SEVEN HUNDRED SIXTY THOUSAND DOLLARS (\$760,000) BETWEEN PROJECTS, AND WITHIN DEPARTMENTS, ACCOUNTS, AND SUBFUND 4282 (2020 GO BOND FUND ISSUE 2), AS FOLLOWS:
