### CERTIFICATE OF SECRETARY OF THE CITY COUNCIL

WHEREAS, on September 27, 2018, a request attached hereto as Exhibit "A", was received by the undersigned to place proposed amendments to Titles 43-H, Tulsa Revised Ordinances, on the agenda of the City Council;

WHEREAS, Title 43-H, Subsection 100.B., Tulsa Revised Ordinances, specifically prohibits the Secretary of the Council from placing the issue of amendment or repeal of those titles on the Council's agenda until the Secretary has: (1) within twenty-four hours of receipt of the request notified all major newspapers, all television stations, all radio stations located within the City; (2) notified the general public by a press conference held at City Hall, officially called by the Secretary, to which all major newspapers, all television stations and all radio stations located within the city have been invited; (3) caused public notice to be given in the Tulsa World, and the Oklahoma Eagle setting forth the nature, purpose, and extent of the request and the date the matter is to be first placed on the Council agenda, and caused the same to be published once a week for the two consecutive weeks, with the first publication being more than fifteen days prior to the request being placed on the agenda of the City Council; and, (4) executed, filed with the City Clerk and delivered to the City Council written certification as to the time and manner of the performance of the foregoing duties, which certification shall be made part of the permanent records of the City in the office of the City Clerk and be available for inspection and copying at all reasonable times.

NOW, THEREFORE, I Lori Doring, secretary of the Council of the City of Tulsa, Oklahoma, do hereby certify that:

1. On September 28, 2018 (within twenty-four hours of the request) I notified all major newspapers, all television stations and all radio stations within the City of Tulsa of the request for amendment to 43-H, Subsection 100.B., Tulsa Revised Ordinances, attached hereto as Exhibit "A";
2. I notified the general public by a press conference which was held on October 9, 2018, at 3:00 P.M. in Room 411 of City Hall, to which all major newspapers, all radio stations, and all television stations located within the City were invited;

3. I caused public notice to be given the Tulsa World, and the Oklahoma Eagle specifically setting forth the nature, purpose, and extent of the request, and the date and time of October 24, 2018, 5:00 P.M. when the matter was first placed on the Council's agenda for public hearing, the first publication of the notice being on October 1, 2018, which was more than fifteen days before the date of the first public hearing, and the second publication of the notice being on October 8, 2018, and the proof of publication being attached hereto as Exhibit "B" and
4. I have filed a copy of this Certificate in the office of the City Clerk of the City of Tulsa, Oklahoma to become a part of the permanent records of the City and to be available for inspection and copying at all reasonable times.
