***4. TABULATION OF BIDS, RECOMMENDATIONS OF AWARD & APPROVAL TO EXECUTE CONTRACT**

- a. **Award of Bid – Contract No. 139315 – Daris Contractors, LLC – TMUA-W 25-08 - \$2,760,217.00 – Approve – Tom Prag.** Submitted is the Tabulation of Bids and Recommendation of Award for Project No. TMUA-W 25-08 Yahola Terminal Storage Reservoir Improvements. Bids were received April 17, 2026. The Engineers Estimate prepared by Keithline Engineering Group, PLLC for Total Base Bid plus Additive Alternate 1 for \$2,636,487.75. Three (3) bids were received ranging from \$2,760,217.00 to \$3,879,000.00 for Total Base Bid plus Additive Alternate 1. Daris Contractors, LLC submitted the lowest bid for \$2,760,217.00 for Total Base Bid plus Additive Alternate 1. Construction duration 285 days. RECOMMEND APPROVAL (Tracking No. UB0121949) (Contract No. 139315)
- b. **Award of Bid – Contract No. 139361 – Walters-Morgan Construction, Inc. – ES 2024-17 - \$1,776,166.00 – Approve – Tom Prag.** Submitted is the Tabulation of Bids and Recommendation of Award for Project ES 2024-17 Citywide Lift Station Improvements Cherokee Park Lift Station. Bids were received April 24, 2026. The Engineers Estimate prepared by HUB Engineering for Base Bid Plus Additive Alternate No. 1 for \$1,641,686.00. Three (3) bids were received ranging from \$1,776,166.00 to \$1,854,886.00 for Base Bid plus Additive Alternate No. 1. Walters-Morgan Construction, Inc. submitted the lowest bid for \$1,776,166.00 for Base Bid plus Additive Alternate No. 1. Construction duration 365 days. RECOMMEND APPROVAL (Tracking No. WS0121958) (Contract No. 139361)
- c. **Award of Bid – Contract No. 139413 – Walters-Morgan Construction, Inc. – WPC26-1 - \$3,671,000.00 – Approve – Cindy Cantero.** Submitted is the Tabulation of Bids and Recommendation of Award for TMUA Project No. WPC26-1 FY '26 Water Pollution Control Capital Equipment Replacements. Bids were received on April 24, 2026. Two responsive bids were received for the project ranging from a low of \$4,005,000.00 to a high of \$4,250,500.00. Walters-Morgan Construction, Inc. was the apparent low bidder in the amount of \$4,005,000.00. The Engineers Estimate for the total of all bid items (Basis of Award) was \$3,880,831.00. We recommend award of the Base Bid and Additive Alternates 2 and 3 for a total award amount of \$3,671,000.00. RECOMMEND APPROVAL (Tracking No. WS0121969) (Contract No. 139413)

- a. **Change Order No. 3 – Contract No. 137337 – Daris Contractors, LLC – TMUA ES 2009-07 C2 P2 – \$0.00 – Approve – Tom Prag.** Submitted is Change Order No. 3 to Contract 137337, between the Tulsa Metropolitan Utility Authority and Daris Contractors, LLC, for Project No. TMUA ES 2009-07, Contract 2 Phase 2 East 53rd Street and Riverside Drive: Cherry Creek Lift Station Pump Restoration and Force Main Improvements, in the amount of 305 calendar days is necessary for time reconciliation associated with delays on project. Delays include working through instrumentation and control (I&C), pump 2 vibrational issues, and time delay on execution of change order 2. RECOMMEND APPROVAL (Tracking No. WS0121716) (Contract No. 137337)

***6. MISC. ACTION ITEMS**

- a. **New Contract – Contract No. 139234 – Carollo Engineers, Inc. – TMUA-W 26-05 - \$236,550.00 – Approve – Tom Prag.** Submitted is an agreement for Professional Engineering Services between the Tulsa Metropolitan Utility Authority and Carollo Engineers, Inc. for TMUA Project No. TMUA-W 26-05, Unruh Intake Valve Replacement. The scope of this project includes conducting a bathymetric survey, updating construction BCE, creating a BCE for future dredging operations, pre-bid services, and writing an RFP/IFB for valve replacement and sediment displacement to be distributed and processed by the Purchasing Department to solicit bids for the replacement work. There are (6) butterfly valves and associated manual actuators that need replacement. The bathymetric survey will allow the consultant to determine amount of sediment in the reservoir, provide base level volume sediment displacement, and acquire information to create a BCE for dredging of the reservoir in the future. PCSSC Selection Date: July 7, 2025, PCSSC: April 15, 2026. RECOMMEND APPROVAL (Tracking No. UB0121933) (Contract No. 139234)
- b. **New Contract – Contract No. 139187 – Jacobs Engineering Group, Inc. – TMUA-W 26-08 - \$250,000.00 – Approve – Tom Prag.** Submitted is the agreement for Professional Engineering Services between the Tulsa Metropolitan Utility Authority and Jacobs Engineering Group, Inc. for Project No. TMUA-W 26-08, TMUA Water Hydraulic Modeling Support Services for an amount of \$250,000.00. Agreement provides ongoing citywide water modeling support for Fiscal Year 27. This includes 1) updates and improvements to the hydraulic models for the primary and secondary pressure zones, 2) hydraulic model calibration and analysis, 3) recommendations for updates to the water system capital program, 4) development, calibration, and analysis of hydraulic models, 5) assessment of water system impacts from proposed major land developments, 6) development of a water modeling standards handbook, and 7)

in-person TMUA staff training on hydraulic model. Engineering Firm selected at ESC: January 14, 2026. PCSSC: April 15, 2026. RECOMMEND APPROVAL (Tracking No. UB0121929) (Contract No. 139187)

- c. **Amendment No. 1 – Contract No. 139929 – Carollo Engineers, Inc. – ES 2026-03 - \$665,360.00 – Approve – Tom Prag.** Submitted is Amendment No. 1 to the Agreement for Professional Engineering Services for TMUA Project No. ES 2026-03, Southside Wastewater Treatment Plant (SSWWTP) Concrete Rehabilitation & Replacement. The agreement provides engineering design and construction phase services for the Southside Wastewater Treatment Plant (SSWWTP) Concrete Rehab and Replacement project. This project consists of replacement of degraded conveyance structures and pipelines at the SSWWTP from the influent force mains discharge to the influent flume through the primary clarifiers' influent and effluent pipelines, bypass structure and pipeline, intermediate lift station influent and effluent pipelines. This agreement specifically excludes investigation, study, and design of concrete rehabilitation at the primary clarifier's structures and intermediate lift station structure. The original Agreement in the amount of \$147,500.00 and Amendment No. 1 in the amount of \$665,360.00 increases the total contract amount to \$812,860.00. PCSSC: April 1, 2026. RECOMMEND APPROVAL (Tracking No. UB0121449) (Contract No. 139929)
- d. **Amendment No. 1 – Contract No. 140111 – Kimley-Horn and Associates, Inc. - \$43,268.26 – Approve – Tom Prag.** Submitted is the amendment to add approximately 2,650 linear feet of waterline on W. Oklahoma Street to the existing ongoing design. This will require additional survey and design work. Org. contract in the amount of \$249,155.23 and the Amendment No. 1 in the amount of \$43,268.26 increases the total contract amount to \$292,423.49. PCSSC: April 15, 2026, TMUA 5-13-26. RECOMMEND APPROVAL (Tracking No. UB0121596) (Contract No. 140111)
- e. **Renewal – Contract No. 138864 – Department of the Interior – USGS - \$148,384.00 – Approve – Dustin Davis.** Submitted for approval is the second renewal of the Annual joint-funding agreement SJJFAOK011010 between the U.S. Geological Survey Oklahoma-Texas Water Science Center and Water and Sewer Water Supply Systems, during the period July 1, 2026 through June 30, 2027. It is for the operation and maintenance of surface quality monitoring station in support of the Tulsa Metropolitan Utility Authority's (TMUA) permits. U.S. Geological Survey contributions for this agreement are \$102,400.00 and the Tulsa Metropolitan Utility Authority's contributions are \$148,384.00 for a combined total of \$250,784.00. RECOMMEND APPROVAL (Tracking No. UB0121305) (Contract No. 138864)

- f. **Ordinance Adjust Water and Sewer Rates – Title 11C – Waterworks and Sewerage – Approve – Jhoanna Murray.** An ordinance amending Title 11-C, Tulsa Revised Ordinance Titles “Waterworks and Sewerage”, Amending Sections 302, 303, 304, 305, 306, 307, and 308 to provide water and sewer rate adjustments amending Chapter 7, Title “Sanitary Sewer User System”; amending sections 702, 703 and 708 to adjust sewer service charge rates; amending sections providing that these rates shall be effective on October 1, 2026; establishing when the amendments enacted by this ordinance shall become operative; and providing for severability. Water rates are adjusted based on cost of service to provide six (6) percent additional revenue to water fund. Sanitary Sewer rates are adjusted based on cost of service to provide three (3) percent additional revenue to the sewer fund. RECOMMEND APPROVAL
