## CLASS TITLE: VOLUNTEER AND COMMUNITY OUTREACH COORDINATOR

**PURPOSE OF THE CLASSIFICATION:** Under general supervision is responsible for increasing Tulsa Animal Welfare (TAW) volunteer programs, activities and services, and oversees community outreach activities and events; and performs other related assigned duties.

## **ESSENTIAL TASKS:**

- Plans and attends special adoption events
- Coordinates transportation and proper animal preparation
- Ensures the appropriate animals, volunteers, and supplies are available
- Schedules and conducts community presentations and provides information on animal welfare, pet ownership responsibilities, dog bite prevention and other animal-related topics
- Plans and coordinates volunteer program including recruiting, orientation, training and making work assignments based on program needs and individual interests
- Oversees and directs the work of volunteers
- Educates on responsible animal guardianship, animal care and local ordinances
- Provides quality in-person and telephone client service
- Maintains and prepares a variety of records and files
- Must report to work on a regular and timely basis

## Reasonable accommodations may be made to enable individuals with disabilities to perform the essential tasks.

## **QUALIFICATIONS:**

<u>Training and Experience</u>: Graduation from and accredited college or university with an associate's degree in communications, public relations, liberal arts or other related fields and two (2) years of experience in the care and handling of animals including at least one (1) year of customer service experience in a fast paced environment with a variety of client needs; or an equivalent combination of training and experience per Personnel Policies and Procedures, Section 128.

<u>Knowledge</u>, <u>Abilities</u>, <u>and Skills</u>: Good knowledge of City ordinances related to animal control; good knowledge of the safety requirements of the work performed; working knowledge of dog and cat breeds, diseases, medical conditions, and animal handling and behavior; and knowledge of the geography of the City. Ability to handle animals safely with patience and gentleness; ability to effectively communicate both verbally and in writing; ability to maintain accurate records and reports; ability to work with a diverse group of volunteers; ability to understand and influence the behavior of others within the organization, customers, or the public in order to achieve objectives and cause action or understanding; ability to react quickly and effectively in emergency situations. Skill in using computers and related software applications.

<u>Physical Requirements:</u> Physical requirements include arm and hand dexterity enough to use a keyboard and telephone; frequent standing and walking, lifting up to 40 pounds; frequent carrying up to 10 pounds and occasional carrying up to 60 pounds or more; occasional pushing and pulling up to 60 pounds; frequent balancing, bending, handling, talking, and twisting; occasional kneeling, crawling, feeling, climbing, and smelling; and vision, speech and hearing sufficient to perform the essential tasks.

<u>Licenses and Certificates:</u> Possession of a valid Oklahoma Class "D" Driver's License; possession of Certified Euthanasia Technician certification from the Oklahoma Board of Veterinary Medical Examiners within nine (9) months of hire date.

**WORKING ENVIRONMENT:** Working environment is primarily indoors and occasionally outdoors, and in inclement weather. May be exposed to the following: animal waste/dead animals, traffic, cramped work areas, weather/temperature extremes, rough terrains, damp/wet surfaces, snow/ice covered surfaces, animal bites, insect bites, poisonous plants, toxic fumes/vapors/odors, and loud noises.
