## Sum leh pai lam lak na tawh ki sai ki kup na saung ah bang teng piang theih hiam?

Sum leh pai tawh ki sai na sep na te pan phone pan zong sem theih hi. Lam hong lak ding te ing mii te ih sum leh pai ham sak na tung tawng in hong huh ding ah a ma lang tak in ah a lak khiat theih na ding leh a dang huh na tuam tuam te tung ah ong ki zop sak theih ding hi. Ki kup na pan minute 30 kiim bang sawt theih ding hi. Phone tawh ki hong na sung ah sum leh pai tawh ki sai lam lak siam te in hih dan tuam tuam te hong huh theih ding hi:

- + **A thu pi ma sa a hi, nisim zat lo pha mawh** a hi inn tawh ki sai, ne leh dawn te leh insurance vai cih te.
- + **Na sum lut ong khan sak na ding**, sum leh pai huh na a ki sam vat te, sum tang tawh huh na, sum lei tawi na, na sap neih lo a hih kei leh dam lo pak na tung tawn in ngah theih hi.
- + **Sum leiba zek dan ding a hi**, (credit cards) leiba, sang sum lei tawi na, naupaung pan pih na leh na sum lei tawi na te tawh ong ho lim sak theih ding hi.
- + **Sum leh pai ki khem na te tawh ki pelh na ding.**
- + **Mai lam sum leh pai ham sat loh na ding ki gin kholh na.**
- + **Sum bei lo ah Income Tax a bawl pih mun tuam tuam te ah zong on glut sak theih ding hi.**
