## **Housing Complaint Form**

Pursuant to Title 5, Section 104B(1) of the City of Tulsa City Ordinance (TRO), the following acts shall be unlawful and an offense: For any person or business to discriminate by failing or refusing to sell, rent, lease, sublease, assign or offer for inspection any real property; or by any lending institution who fails to lend, appraise, guarantee loans, accept mortgages or otherwise fail to make available funds for the purchase, acquisition, construction, rehabilitation, repair or maintenance of any real property.
