Overview

TCM Creative is filming a series of commercials for Covenant House International, a national non-profit that supports at-risk and homeless youth. The concepts to be filmed are for a campaign titled "I didn't ask." It tells before and after stories of a homeless teens, and how Covenant House can transform the lives of those they serve. Elements to be filmed include dramatized scenes before and after help, scripted lines, and interviews with real Covenant House Alumni. 

Location Notes

Production home base, craft services, and HMU/Wardrobe will primarily be inside the Powerhouse Building. The 810 interiors will be used for dramatized b-roll, lines, and interviews. Crew Parking (Yellow) will primarily be in the First Presbyterian lot. Additional or overflow parking can utilize the numerous city street parking or paid parking lots nearby.

There will be two filming units:

A-Unit: Exterior entrance of 810, Interior lines and Interviews

Key shots (**RED**) of the exterior of the 810 building will require the use of sidewalks and a few city parking spaces directly in front of the 810 entrances.

- This is estimated to only be a 2–3-hour window on 8/3.
- No traffic interruptions are expected.
- Sidewalk closed signs and/or PA's will be placed on the building corners to help control pedestrian traffic.
- No Parking signage and cones will be utilized to keep the parking spaces required for filming cleared and empty during required filming windows.

B-Unit: Interior/Exterior b-roll and photography

Some exterior b-roll and photography may take require the use of sidewalks in the location area (PINK). This will be a skeleton crew, and is not anticipated to interfere with normal pedestrian traffic, or require any parking/traffic interruptions.

We have been working in close cooperation with Lynn in order to help secure the buildings near First Presbyterian Church, which owns both the Powerhouse and 810 Buildings. The Powerhouse building will be empty besides our production and our production operations are not expected to interfere with any other local business.

At the 810 Building, our production would take place on the ground floor and exteriors. There are tenants in the upper floors, which we will work with Lynn and property management to notify of filming and work to not disrupt any normal business operations. There are 2 primary entrance/exits to the building. We would only require using 1 at any time, so there are only minor interruptions to normal business operations expected. We may be able to further mitigate tenant concerns by filming exteriors after 5pm.
