PURPOSE OF THE CLASSIFICATION: Under general supervision performs works with field supervisors in directing crews and performing skilled and semiskilled labor, such as graffiti abatement, equipment maintenance, street repairs, speed hump installation, and infrastructure conditions; and stormwater utilities maintenance other related assigned duties.

ESSENTIAL TASKS:

- Performs leadwork, such as prioritization of work, problem solving, and decision making to ensure adherence to City safety procedures and efficiency and accuracy of work performed
- Provides reports to management concerning work progress, operational concerns, and work planning.
- Leads crew in performing a variety of departmental functions, including graffiti abatement, street repairs, and all facets of stormwater related maintenance and operations
- Operates specialized electronic equipment/heavy Equipment
- Completes and maintains accurate documentation for each project in Lucity.
- Ability to read and understand the Stormwater Atlas.
- Maintains worksite safety, assuring proper placement of traffic signs, barricades, and other related gear to ensure the safety of employees and citizens
- Serves as a liaison with internal and external customers, including vendors and contractors
- Directs applicable safety sessions for the work area, ensuring employees understanding of traffic and
 job site safety, and operates, maintains, instructs, and directs others in the safe and proper use of
 various equipment, including hand and power tools
- Must report to work on a regular and timely basis

Reasonable accommodations may be made to enable individuals with disabilities to perform the essential tasks

PAY INCREASE OPPORTUNITY

1st Proficiency. Employee will be eligible for a one step increase:

- Upon completion of three (3) months experience as a Streets & Stormwater Operator V; and,
- Completion of one (1) course credit from the Development Training course Catalog or 1 class from Safety and Training, not previously submitted, as approved by management

2nd Proficiency Employee will be eligible for a second one step increase upon completion of:

- Six (6) months experience as a Streets & Stormwater Operator V; and,
- Completes training on Snow/Ice calibration techniques **or** completion of walking Excavator certification course, not previously submitted, as approved by management; **and**,
- Completion of one (1) course credit from the Development Training course Catalog or one (1) class from Safety and Training, not previously submitted, as approved by management

3RD Proficiency Employee will be eligible for a third one step increase upon completion of:

- Nine (9) months experience as a Streets & Stormwater Operator V; and,
- Completion of two (2) credits from the Development Training course Catalog or from Safety and Training, not previously submitted, as approved by management

Employees requesting proficiency or progression increase must not be on a City Performance Improvement Plan at the time of the request.

QUALIFICATIONS:

<u>Training and Experience:</u> Must meet one of the following options or an equivalent combination of training and experience per Personnel Policies and Procedures, Section 100:

- 1. (a) Graduation from high school or possession of a General Education Development Certificate (GED); **and**,
 - (b) Five (5) years of increasingly experience relevant to the essential tasks listed in this job description; **including**,
 - (c) Three (3) years' experience in street and/or stormwater repairs; or,
 - (d) One (1) year experience in graffiti abatement; and,
 - (e) One (1) year of lead experience.

Knowledge, Abilities and Skills:

Knowledge of:

- Knowledge of a variety of graffiti abatement such as painting, power washing, and soda blasting
- Knowledge of paint matching equipment (spectra-meter) calibration
- Knowledge of materials, tools, and equipment needed for graffiti abatement, street repairs, or stormwater concrete structural work
- Knowledge of tools, materials, and equipment used to perform semi-skilled and skilled labor
- Knowledge of City and Department Policies and Procedures
- Knowledge of Occupational Safety and Health Administration (OSHA)

Ability to:

- Ability to work independently
- Ability to work under pressure
- Ability to lead large crews performing various duties, including, but not limited to asphalt overlays, speed hump installation, and other street repairs, and stormwater related issues such as erosion, concrete, and storm sewer repairs.
- Ability to use and instruct others in the proper use of tools, equipment, and materials
- Ability to document all applicable records and data for projects
- Ability to train others and assist with the evaluation of employees
- Ability to understand and influence the behavior of others within the organization, customers, or the public in order to achieve job objectives and cause action or understanding

- Skill in communicating to a diverse customer base
- Skill in organizing, compiling, and recording data

<u>Physical Requirements:</u> Physical requirements include frequent walking and standing; frequent lifts/carries up to 60 pounds; frequent pushing up to 50 pounds; occasional lifts/carries up to 105 pounds; occasional pushing up to 60 pounds; frequent pulling up to 60 pounds; frequent reaching, balancing, bending, kneeling, handling, climbing, smelling and twisting; occasional crawling and feeling; and vision, speech and hearing sufficient to perform the essential tasks.
