Event Description: The 4th annual Audacity: Osage County gravel bike race will take place on Saturday, August 2, 2025, beginning at 6:00 p.m. in Downtown Tulsa. The event will start and finish at Soundpony Bar, located at 409 N. Main Street. This unsanctioned, mixed-surface cycling event draws riders from across the region and offers two route options: a full 69-mile loop and a 44-mile "Rest Stop Raiders" out-and-back course. Both routes traverse city streets, paved roads, and rugged gravel sections through Osage County, featuring rolling terrain and several short, steep climbs. Designed as an evening ride in Oklahoma's summer heat, the race includes checkpoints and minimal on-course support. Participants are required to use lights and are encouraged to be self-sufficient. The ride concludes with a post-race celebration at Soundpony. This event promotes healthy outdoor recreation, bicycle culture, and community engagement in downtown Tulsa and surrounding rural areas.

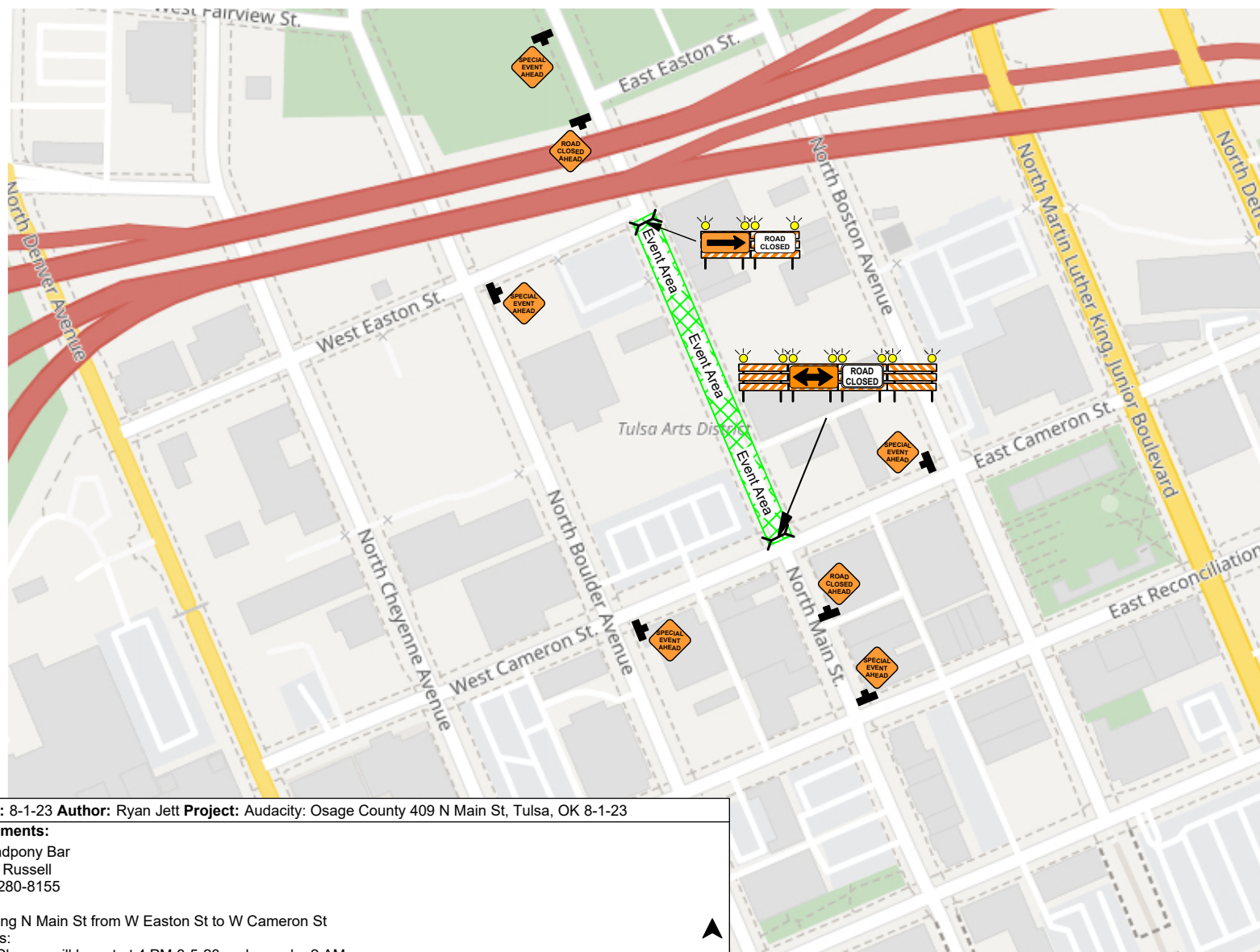

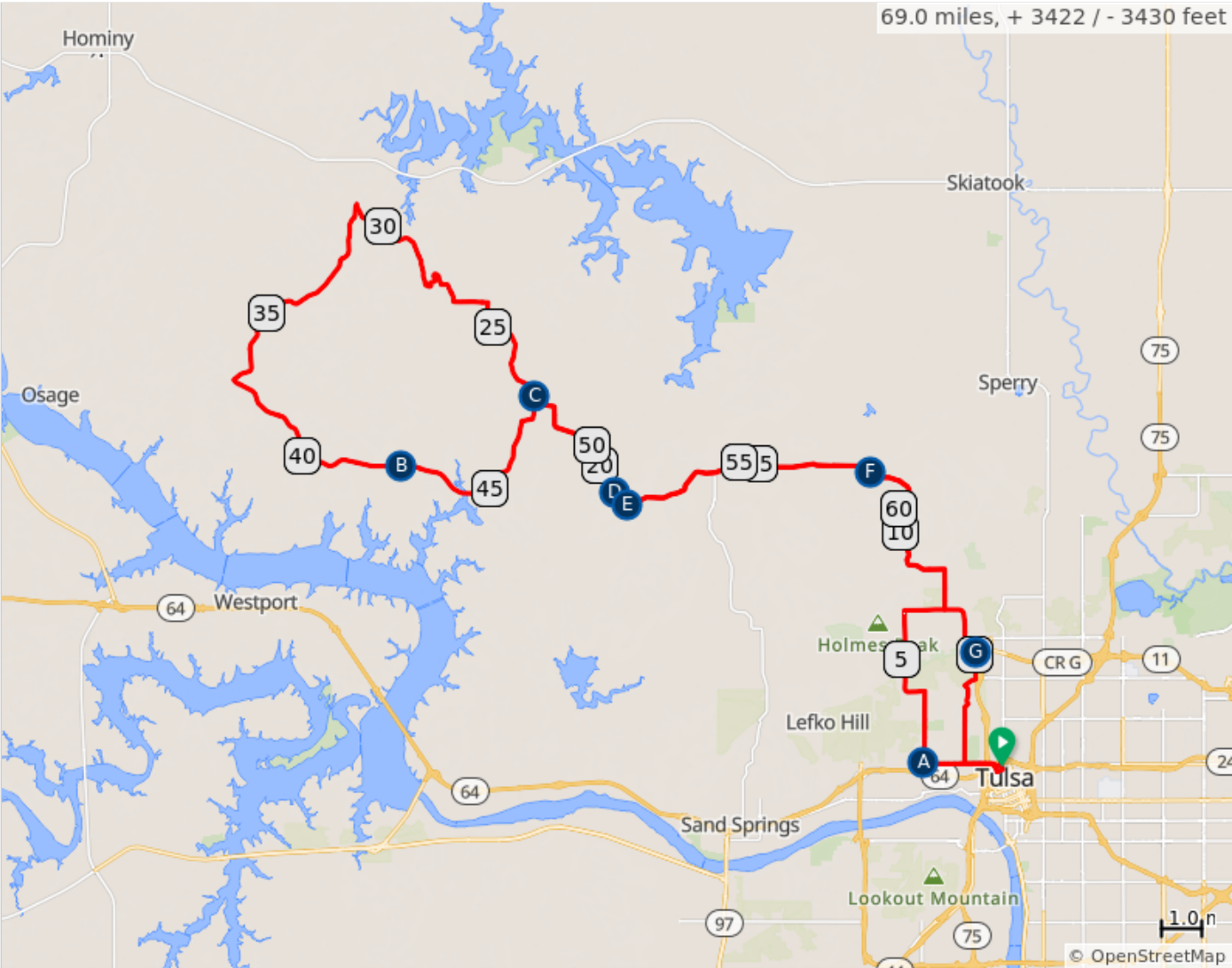

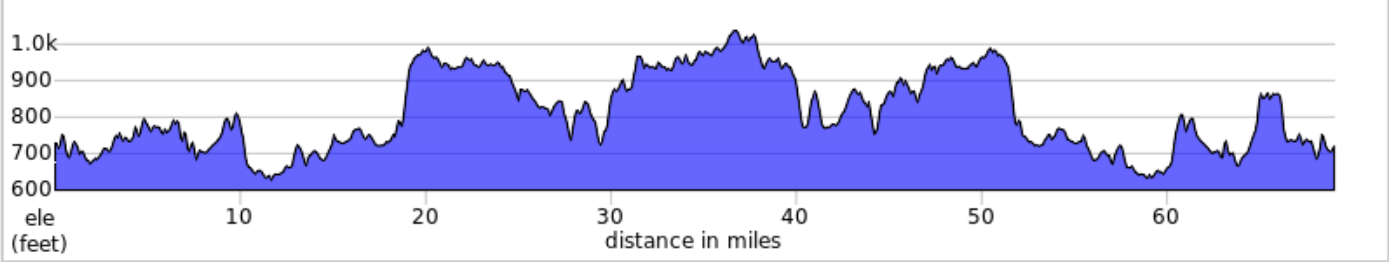


2024 | Audacity: Osage County

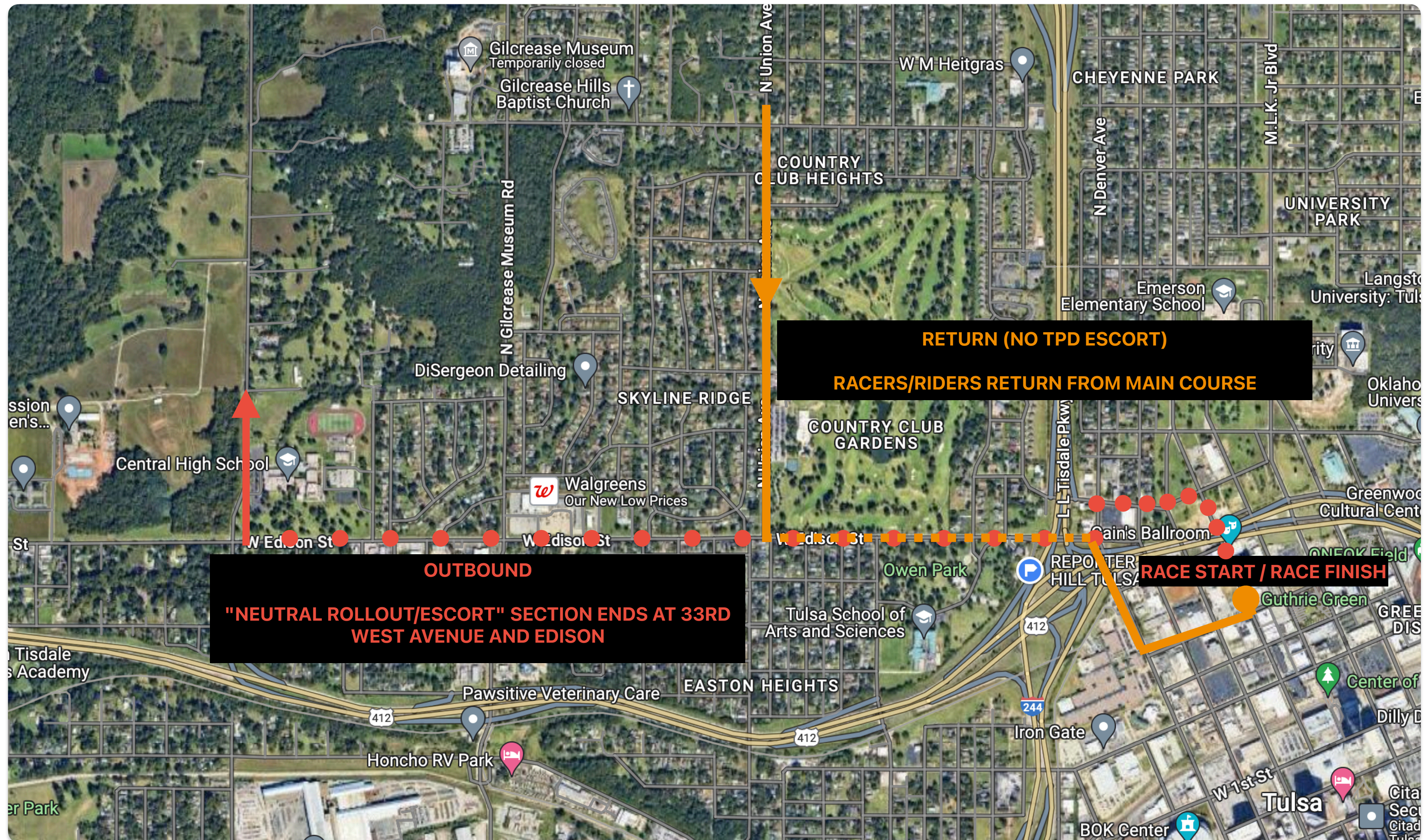
