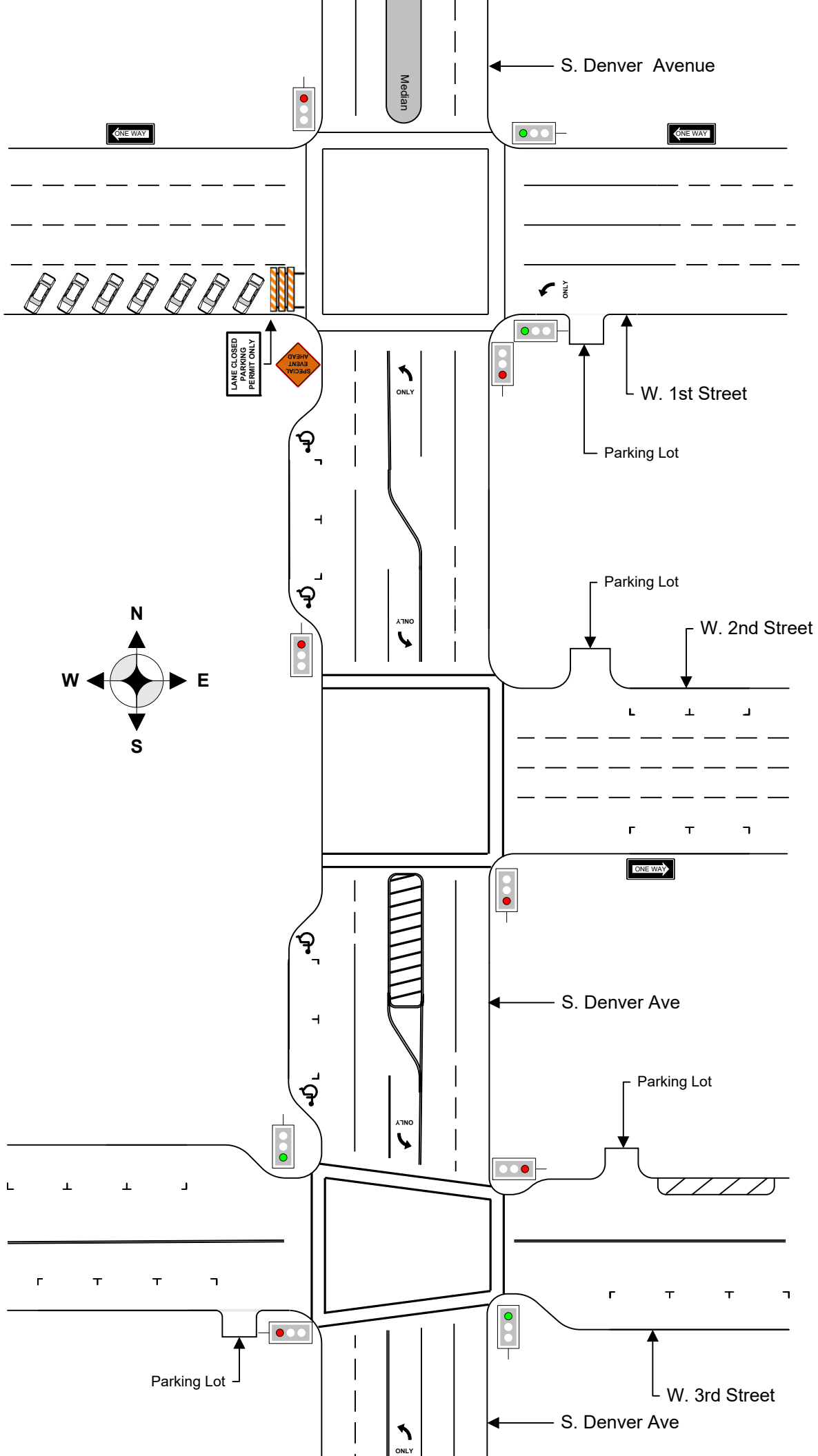

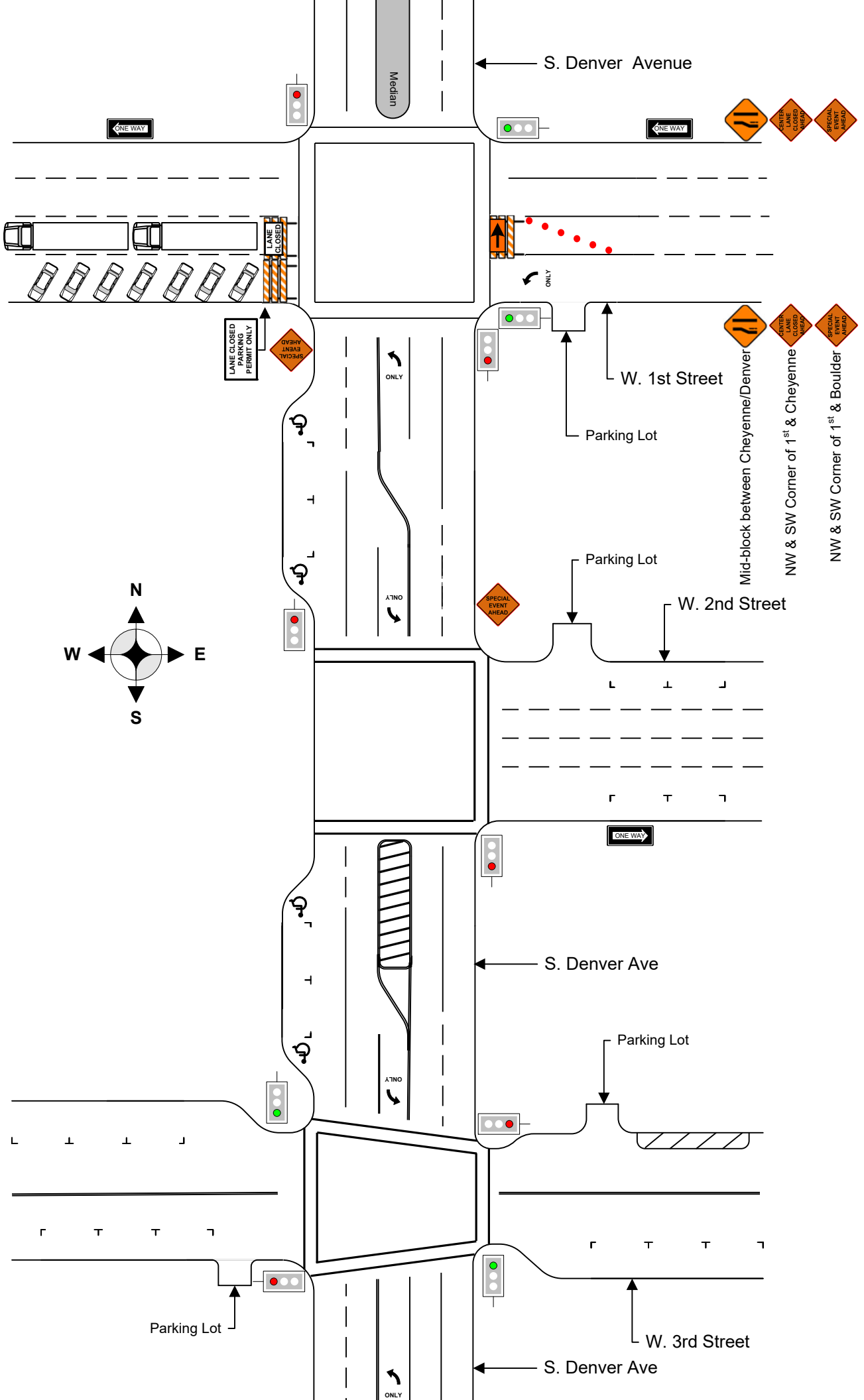

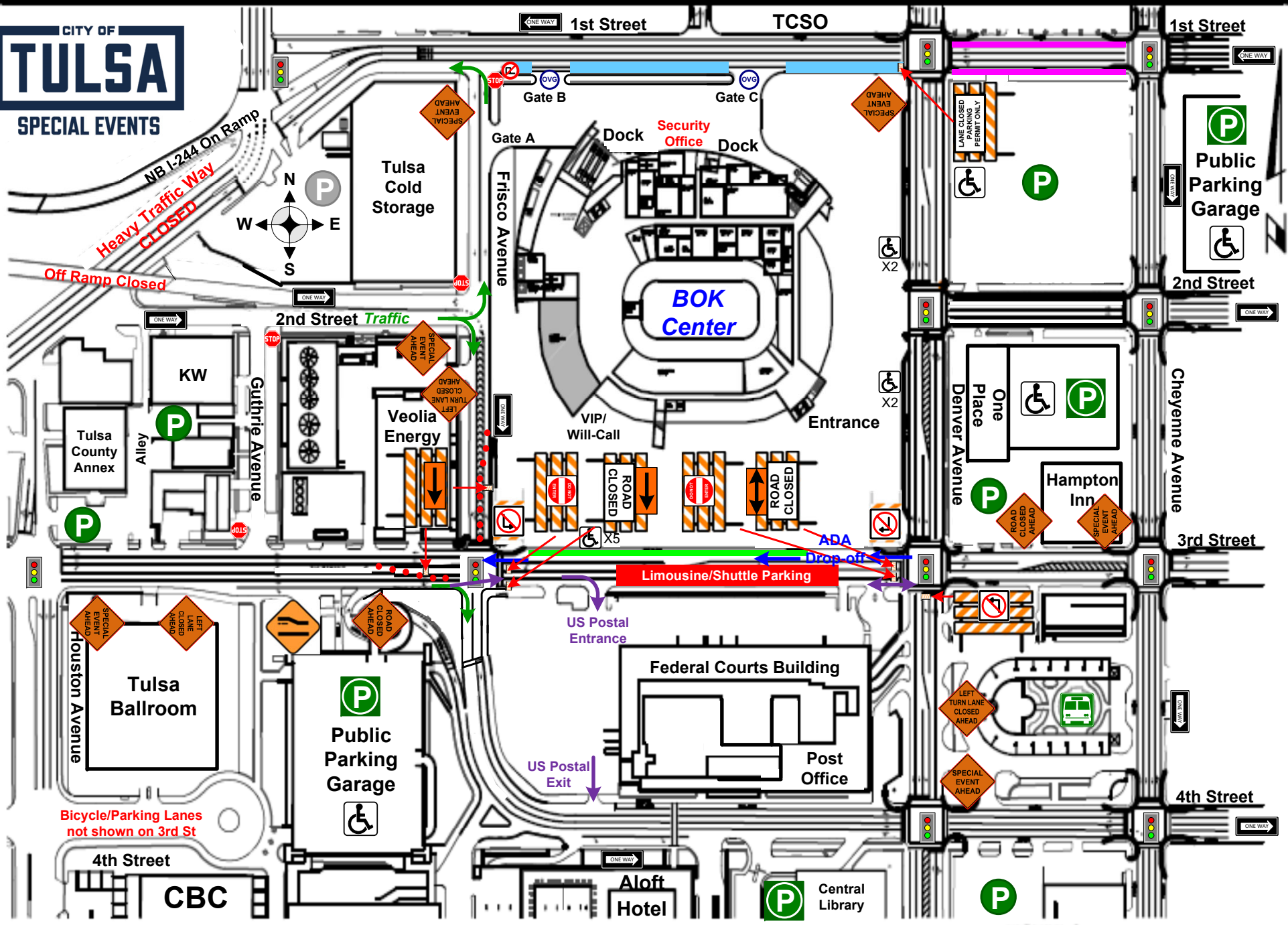

Map of Frisco Ave, 2nd St - 3rd St

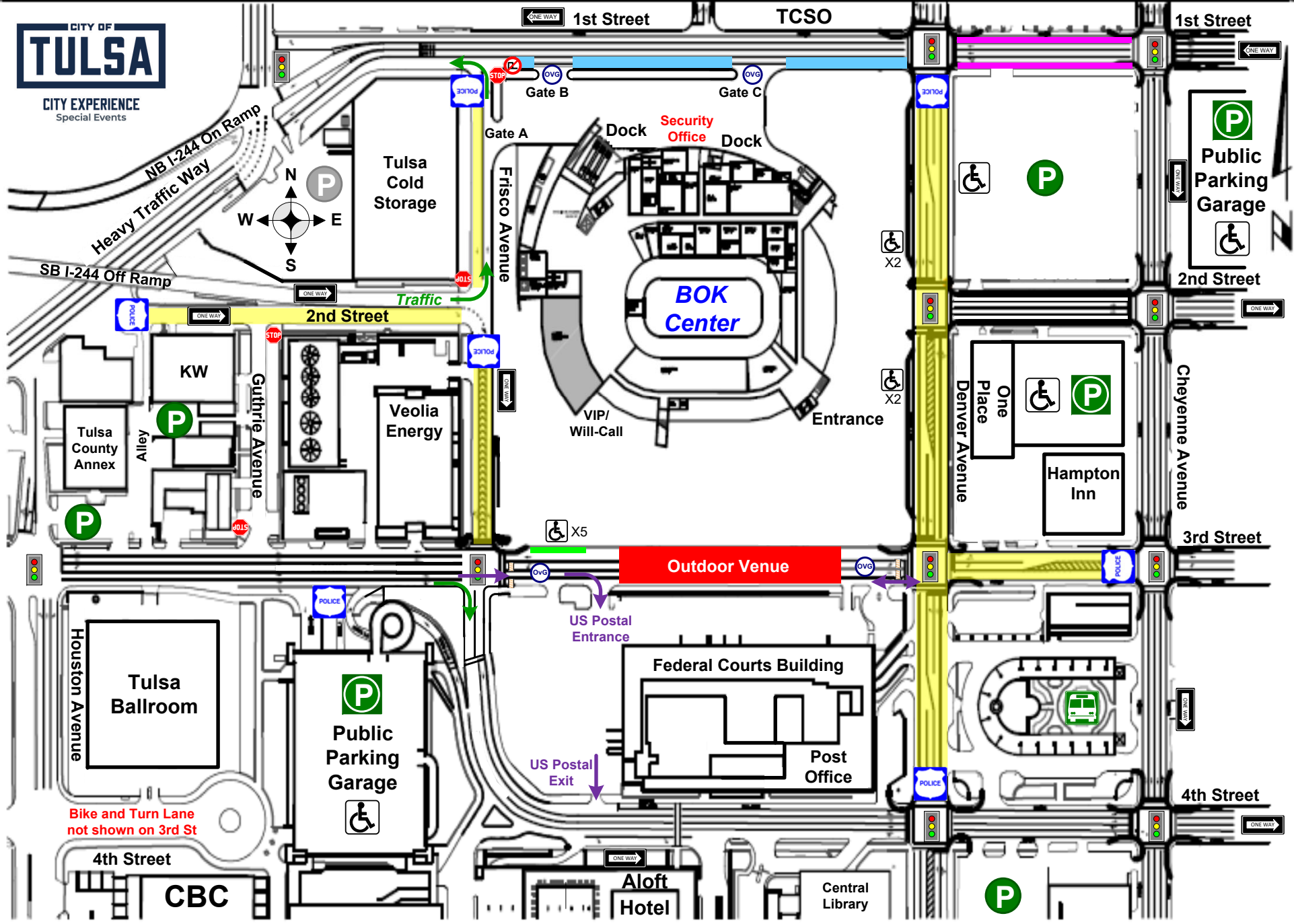


Map of 3rd St between Houston Ave and Frisco Ave
