- 1. Q: Who is your current supplier?
  - A: Truman Arnold Companies
- 2. Q: Please provide copies of invoices and bill of ladings for each product.
  - A: See below images
- 3. Q: Are bidders required to bid on the B5 and B10 diesel?
  - A: We have removed these bid items from this IFB.
- 4. Q: Can bidders choose not to bid the B5 and B10?
  - A: We have removed these bid items from this IFB.
- 5. Q: Do you wish to be priced off of the Net OPIS value or Gross OPIS value?
  - A: Net Tulsa OPIS value
- 6. Q: In the OPIS example provided in the bid the index is Net OPIS average. Is this how you wish it to be priced?
  - A: YES
- 7. Q: Can suppliers use common carriers to make the deliveries?
  - A: Yes
- 8. Q: In the event that a bidder is the second lowest bidder, will that bidder have the choice not to enter into a contract to be the secondary supplier?
  - A: Yes
- 9. Q: Will deliveries have to be made by company owned trucks?
  - A: If you mean trucks owned by the bidder, then no, we do not require the transport units to be owned by the City of Tulsa's supplier.
- 10.Q: Please provide tank details for each site (ex. Type of fuel, tank size, above/below ground)
  - A: U/L & Diesel: 8,000 to 12,000 gallon tank size. 4 tanks are above ground. Check bid document for locations. All in Tulsa metro area.
- 11. Q: Please provide the annual volume per site.
  - A: In total, U/L 1,400,000 gallons; Diesel 840,000 gallons. Check bid document for locations. All in Tulsa metro area.
- 12.Q: What are the contract term dates and if awarded, is the contract renewable?
  - A: As stated in the Terms and Conditions, #4, the contract is for one year beginning on the date the Mayor signs the contract and has four annual renewal options. These renewals are not implied or guaranteed. They are options which may be exercised by mutual agreement.

13.Q: Regarding the Bidder's Questionnaire, number 2, are you looking for the location and contact info of the "local" supply outlet in which our corporate office is located?

A: We are wanting to know the location and contact info for the supply outlet which is local to the Tulsa area.

14. Q: Do you consider common carriers as subcontractors?

A: For the purposes as stated in the Purchase Agreement, item #26, "Seller may not assign this Agreement or use subcontractors to provide the Goods and/or Services without City's prior written consent," No, we do not consider common carriers as subcontractors.

- 15.Q: Will you accept gasoline with up to 10% ethanol?
  - A: Yes
- 16. Q: Is the gasoline required to be ethanol free?
  - A: No
- 17. Q: The pricing sheet denotes that we are to use the AFI index for B5 and B10. That index is seldom used for these products. In every other national bid we participate in we use a PLATTS or an OPIS index. Can we use an OPIS index to complete both b5 and b10 portions?
  - A: We have removed these bid items from this IFB.
- 18.Q: What is the award date?
  - A: The date the Mayor of the City of Tulsa signs the contract document.
- 19.Q: When is the first board meeting after the bid opening?
  - A: I'm not sure what you mean by "board meeting." There is no reference to a "board" in the bid specification.
- 20.Q: Will a decision be made before or at the board meeting?
  - A: Again, I'm not sure to what "board" you are referring. No decisions will be made at the bid opening. A committee of City employees will evaluate the bids and a recommendation for award will be presented to the City's Standards, Specifications and Awards (SSA) committee. All bidders will be notified prior to presenting the recommendation to the SSA committee.
- 21.Q: Do want priced off the Tulsa OPIS?
  - A: Yes
- 22.Q: Will you split award by product?
  - A: No
- 23. Q: Do you allow for deliveries to be split between locations? Between fuel types?
  - A: Yes
- 24.Q: What will be read aloud at the bid opening?

- A: Most likely the Total Annual Cost Transport Load from Exhibit A.
- 25. Q: Is the total annual cost to be calculated using just the Estimated Gallons and Unit Cost (+/-)?

  A: Yes, but please keep in mind that this is an estimate only. Actual fuel purchases may be less or more depending on actual consumption.
- 26. Q: Are your tanks above ground or underground?
  - A: Most are Underground, with 2 locations having Above Ground tanks.
- 27.Q: What are your average delivery sizes per fuel type?
  - A: Unleaded: 8,000-8,500 gallons; Diesel:7,000-7,500 gallons
- 28.Q: For the Bio-Diesel Fuel, you list that it is to be priced off the AFI (Alternative Fuel Index). Can you please advise what Index this is, as we cannot seem to find a publication named such. Also, they to be priced off Tulsa? Tulsa does not supply B5 or B10, but Oklahoma provides B5, and Little Rock provides B5 and B10, would it be okay to use these cities for pricing?
  - A: We have removed these bid items from this IFB.
- 29.Q: How long has Truman Arnold Companies been your supplier?



- 3. Irrevocable Offer. Seller understands and acknowledges that its signature on this Agreement constitutes an irrevocable offer to provide the Goods and/or Services. There is no contract unless and until City's Mayor/Mayor Pro Tem executes this Agreement accepting Seller's Bid. No City officer, employee or agent except the Mayor (or Mayor Pro Tem) has the authority to award contracts or legally obligate the City to any contract. Seller shall not provide any Goods and/or Services to City pursuant to this Agreement before this Agreement is executed by City. Accordingly, and pursuant to Oklahoma law, City shall not indemnify nor hold Seller harmless for loss, damage, expense or liability arising from or related to this Agreement, including any attorneys' fees and costs. 18. **Relationship of Parties.** The Seller is, and shall remain at all times, an independent contractor with respect to activities and conduct while engaged in the performance of services for the City under this Agreement.
