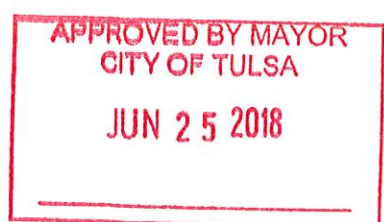

EXECUTIVE ORDER NO. 2018-05

ABOLISHING THE DIVISIONS OF PLANNING AND DEVELOPMENT, THE DIVISION OF RESILIENCE, AND THE MAYOR'S OFFICE OF HUMAN RIGHTS; ESTABLISHING THE DIVISION OF PLANNING AND COMMUNITY DEVELOPMENT, THE DIVISION OF ECONOMIC DEVELOPMENT, THE DIVISION OF RESILIENCE AND EQUITY, AND THE MAYOR'S OFFICE OF RESILIENCE AND EQUITY; SUPERSEDING ALL PREVIOUS EXECUTIVE ORDERS IN CONFLICT HEREWITH

WHEREAS, Article III, Section 1.6 of Tulsa's Revised Charter provides that the Mayor may, by executive order, create or abolish divisions for the management of the departments of the city; and

WHEREAS, the purpose of this organizational structure is to support the efficient and effective operation of City Government, and to reinforce the provision of reliable and responsive services to the Citizens of Tulsa.

NOW, THEREFORE, BY VIRTUE OF THE POWER VESTED IN ME AS THE MAYOR OF THE CITY OF TULSA, OKLAHOMA, IT IS HEREBY ORDERED:

SECTION 1. The Division of Planning and Development, the Division of Resilience, and the Mayor's Office of Human Rights, as previously configured, are hereby abolished.

SECTION 2. There is hereby created a **Division of Planning and Community Development**, which shall consist of the Planning Department, as well as such sections, agencies, and employees as may be necessary to accomplish the duties and functions assigned to said Division, including the City of Tulsa's relationship to and with INCOG and the Metropolitan Tulsa Transit Authority.

SECTION 3. There is hereby created a **Division of Economic Development**, which shall consist of the Mayor's Office of Economic Development and the Development Services Department, as well as such sections, agencies, and employees as may be necessary to accomplish the duties and functions assigned to said Division.


SECTION 4. There is hereby created a **Division of Resilience and Equity**, which shall consist of the **Mayor's Office of Resilience and Equity**, hereby created, as well as such sections, agencies, and employees as may be necessary to accomplish the duties and functions assigned to said Division.

SECTION 5. This Executive Order supersedes all conflicting executive orders.

SECTION 6. This Executive Order shall take effect on the 1st day of July, 2018.


