I. STATEMENT OF PURPOSE:

With this Competitive Sealed Proposal (CSP) request, the City of Tulsa (City) is seeking to secure services with one or more Internet Service Providers (ISP) capable of providing redundant enterprise-class full-duplex Internet service to two locations.

We enthusiastically look forward to receiving your proposal.

II. <u>INSTRUCTIONS FOR SUBMITTING A PROPOSAL:</u>

A. General Requirements

 The proposal must be received by 5:00 p.m. on Wednesday, March 06, 2019, Central Standard Time. Proposals must be sealed in an envelope or box clearly labeled "TAC1165A CSP Internet Services.

Proposals arriving late will be returned unopened.

- 4. All interested Respondents (Sellers) are required to register with the Buyer, Terry Thomas, to receive updates, addenda or any additional information required. The City is not responsible for any failure to register.
- 5. Inquiries to the Buyer requesting clarification regarding this CSP request or the content herein must be made via e-mail and must be received prior to the end of the business day on **February 18, 2019.**

Any questions regarding this CSP request will be handled as promptly and as directly as possible. If a question requires only clarification of

CSP request instructions or specifications, it will be handled via email, or verbally. If any question results in material changes or additions to the CSP request, those changes or additions will be forwarded to all registered Respondents as quickly as possible by addendum.

- 6. Respondents shall designate a contact person, with appropriate contact information, to address any questions concerning a proposal. Respondents shall also state the name and title of individuals who will make final decisions regarding contractual commitments and have legal authority to execute a contract on the Respondent's behalf.
- **7.** Proposals will be opened on the morning after the due date, at 8:30am, at the:

B. General Notifications

- 1. With this Competitive Sealed Proposal request, the City reserves the right to do the following:
 - a. To conduct oral or written discussions with Respondents, after proposals are received, concerning technical and Price aspects of the proposals and/or to allow Respondents to revise their proposals, including Price;
 - b. To evaluate, after proposals are received, the relative abilities of Respondents to perform, including their technical or professional experience and/or expertise;
 - c. To conduct a comparative evaluation, after proposals are received, of the differing Price, service, quality, contractual factors, technical content and/or technical and performance capability of the proposals;
 - d. To negotiate mutually agreeable terms in a contract;
- 2. The City of Tulsa notifies all possible Respondents that no person shall be excluded from participation in, denied any benefits of, or otherwise discriminated against in connection with the award and performance of any contract on the basis of race, religious creed, color, national origin, ancestry, physical disability, sex, age, ethnicity, or on any other basis prohibited by law.
- **3.** All Respondents shall comply with all applicable laws regarding equal employment opportunity and nondiscrimination.

4. All Respondents shall comply with the Americans with Disabilities Act (ADA) and all proposals and any subsequent contract shall include the following statement:

"Contractor shall take the necessary actions to ensure its operations in performance of this contract and its employment practices are in compliance with the requirements of the Americans with Disabilities Act."

It is understood that the program of the Respondent is not a program or activity of the City of Tulsa. The Respondent agrees that its program or activity will comply with the requirements of the ADA. Any costs of such compliance will be the responsibility of the Respondent. Under no circumstances will the Respondent conduct any activity which it deems to not be in compliance with the ADA.

- **5.** Although it is the City's intent to choose only the most qualified Respondents to interview, the City reserves the right to choose any number of qualified finalists for interview and/or final selection.
- 6. This Competitive Sealed Proposal request does not commit the City of Tulsa to pay any costs incurred in the submission of a proposal or the costs incurred in making necessary studies and designs for preparation thereof, or contract for service or supplies.

III. SCOPE OF WORK:

The following describes the service locations and minimum requirements:

- 1. One Technology Center (OTC) 175 E 2nd Street This site is our single existing location and is primary to the City's operations. Dual entry of facilities for two carriers currently exists at OTC. Using dual entry at this site is strongly preferred, however the City will not be responsible for any costs involved with building out the Respondent's infrastructure.
- 2. **911 Call Center**, 809 E Oklahoma Place This site is an expansion to what we currently have in place. Single entry is acceptable at this site.
- Both sites must have full participation in Border Gateway Protocol (BGP) tables.
 The City will control the BGP routing. The City owns an autonomous system number (ASN), Internet Protocol (IP) IPV6 and IPV4 addresses. The City of Tulsa has its own /19 block of IP V4 addresses and has a /40 block of IP V6 addresses.
- 4. Respondents who are not considered Tier 1 Internet Service Providers must provide proof of <u>at least</u> two redundant upstream providers.
- 5. The City has an internal Change Management procedure and requires that any planned maintenance the Respondent needs to perform be communicated and scheduled with City Network Services. A Change Management meeting is held every Wednesday at 8:30 AM. All Service Providers MUST notify the City IT

- department of any potentially service-affecting scheduled changes by Tuesday noon seven days prior to the scheduled work.
- 6. SIP connectivity is NOT a part of this Bid.
- 7. A high percentage of the City's Internet traffic is inbound and not outbound.
- 8. The ISP must provide all hardware, software, billing services, technical and customer support to the designated point of handoff within the facilities listed in the scope of work. The City expects a demarcation point that provides a physical connection. A wireless solution is not acceptable.
- 9. This bid is only for Internet access and does not include other services such as domain name services (DNS).

IV. SCOPE OF WORK Option

The City will discuss, during the Pre-Bid Conference only, optional methods of accomplishing a "Last Mile" connectivity solution for the 911 Center, which include optional addresses for connecting to the City network.

V. TIME FRAME FOR REVIEW:

The time frame for review of proposals is expected to be three (3) weeks, but City reserves the right to vary that as necessary to meet its objectives.

VI. DELIVERABLES:

The products, services, reports, and plans to be delivered to the City will include:

- **1.** Redundant service connections to each of the two locations listed in the Scope of Work.
- 2. The physical terminations for service are required to support up to 10Gigabit (Gb) bandwidth, although the City will initially use 1Gb.
- 3. Incremental pricing starting at 1Gb up to as much as 10Gb using whatever steps are normal to the ISP's pricing model. The intent is to allow the City to request an increase in bandwidth as a service order or as an addendum to a Master agreement without requiring a new agreement. The City requests that pricing for increases in bandwidth be provided, to allow upgrades under a resulting agreement without rebidding. It is anticipated that in the future the City will be relying more and more on new cloud services, therefore more and more bandwidth will be needed.
- 4. Service Level Agreement (SLA) options. Include information on how issues with the building facility entrance are addressed. Also include information on how a breach of the SLA is handled.
- 5. Technical support seven days per week, twenty-four hours per day (7x24), 365 days per year. Describe the method of engaging the Respondent's technical support team for assistance with troubleshooting issues.
- 6. Service reports, such as bandwidth utilization, and whether a web portal is provided for monitoring our internet metrics. Note: The City is not requiring the Respondent to manage our internet access. The question is to ascertain any tools that may be provided for our benefit.

VII. RESPONDENT AND PROPOSAL REQUIREMENTS:

To be considered, interested Respondents should submit or address the following:

- A. One (1) unbound original and five (5) bound copies of the proposal plus one electronic (1) copy (USB flash drive or CD).
- **B.** A description of the Respondent's qualifications and experience and that of key personnel assigned to this project (and that of each firm proposed as part of the Respondent's team). It is noted that equipment, material and staff shall be provided by the Respondent.
- **C.** A description of previous projects that Respondent's firm has conducted for organizations of similar size and complexity. Provide contact names and telephone numbers of references from these organizations.
- **D.** If awarded, provide a project schedule, identifying beginning and ending dates of work, as well as project target dates.
- E. Describe any optional services offered above those listed as minimum requirements. All pricing must be included on the submitted pricing sheet for those services to be considered.

 Provide pricing for the services as described in SCOPE OF WORK with bandwidth of 1Gb for each of the two locations. Post the pricing for this level of service in the Price Sheet Summary calculated for a total annual cost.
- **F.** Pricing with and without burstable bandwidth can be offered but must be appropriately described.
- **G.** State the ISP Tier level at which their service is considered or the number of transit providers supporting the service.
- **H.** Describe and support the expected latency to the next router hop.
- **I.** Describe the "last mile" infrastructure which will provide delivery to both service locations.
- J. Proposals must be submitted by the party which will provide and invoice the good or service. The solicitation contains several documents that can only be endorsed by the party who will be entering into an agreement with The City of Tulsa. Proposals may be considered where a third party's activities to execute the agreement, facilitate creation and delivery of the documents are completely transparent.
- K. Provide incremental pricing starting at 1 Gb up to as much as 10 Gb using steps that are normal to the ISP's pricing model. The intent is to allow the City to request an increase in bandwidth as a service order or as an addendum to a Master Agreement without executing a new contract.
- **L.** At the discretion of the City, one or more Respondents may be invited to be interviewed for purposes of clarification or discussion of the proposal.
- **M.** Any expenses incurred by the Respondent(s) in appearing for an interview or in any way providing additional information as part of the response to this Competitive Sealed Proposal request are solely the responsibility of the

Respondent. The City of Tulsa is not liable for any costs incurred by Respondents in the preparation of proposals or any work performed by the Respondent prior to the approval of an executed contract by the City of Tulsa. The City assumes no responsibility or liability for any costs you may incur in responding to this CSP request, including attending meetings or contract negotiations.

VIII. EVALUATION OF PROPOSALS:

A panel consisting of not less than 4 City of Tulsa employees will evaluate proposals. Selection shall be determined to be in the best interest of the City as evaluated by the City of Tulsa. The approval of the selected Respondent will be subject to the final determination of the City and will be contingent on the successful completion of a contract between the City and the successful Respondent.

IX. AWARD OF PROPOSALS:

The City evaluates proposals based on the general criteria identified in Tulsa Revised Ordinance (TRO) Title 6, Chapter 4, and listed below:

- 1. The ability, capacity and skill of the Respondent to perform the contract or provide the service required,
- 2. Whether the Respondent can perform the contract or provide the service promptly or within the time specified, without delay or interference,
- 3. The character, integrity, reputation, judgment, experience and efficiency of the Respondent,
- 4. The quality of performance by Respondent of previous contracts or services,
- 5. The previous and existing compliance by the Respondent with laws and ordinances relating to the contract or service,
- 6. The sufficiency of the financial resources and ability of the Respondent to perform the contract or provide the service,
- 7. The quality, availability and adaptability of the Services offered by Respondent to the particular use required,
- 8. The ability of the Respondent to provide future maintenance, support and service related to Respondent's offer,
- 9. Where an earlier delivery date would be of great benefit to the Using Department, the date and terms of delivery may be considered in the Proposal award,

- 10. The degree to which the Proposal submitted is complete, clear, and addresses the requirements in the CSP request specifications,
- 11. If a point system has been utilized in the CSP request specifications, the number of points earned by the Respondent.
- 12. The total cost of ownership, including the costs of supplies, materials, maintenance, and support necessary to perform the item's intended function.
- 13. If an evaluation committee performs the evaluation, the recommendation of such committee.

X. MISCELLANEOUS:

- **A.** Your response to this CSP request will be considered part of the contract, if one is awarded to you.
- **B.** All data included in this CSP request, as well as any attachments, are proprietary to the City of Tulsa.
- **C.** The use of the City of Tulsa's name in any way as a potential customer is strictly prohibited except as authorized in writing by the City of Tulsa.
- D. Your proposal must clearly indicate the name of the responding organization, including the Respondent's e-mail address and web site information, if applicable, as well as the name, address, telephone number and e-mail address of the organization's primary contact for this proposal. Your proposal must include the name, address, telephone number and e-mail address of the Respondent and/or team of Respondents assigned to the City account.
- E. The City is bound to comply with Oklahoma's Open Records Act, and information submitted with your proposal, with few exceptions, is a matter of public record. For specifics on the Oklahoma Open Records Act, see the link below:

City of Tulsa General Contract Terms

It is anticipated that the City of Tulsa will enter into a contract with the selected Respondent for an initial term ending one (1) year from the date of its execution by the City's Mayor, with four (4) one-year renewals available at the option of the City. Contracts entered into by the City of Tulsa generally include, but are not limited to, the following terms:

- 1. Renewals. Contractor understands and acknowledges that any future contracts or renewals are neither automatic nor implied by this Agreement. The continuing purchase by City of the Services set forth in this Agreement is subject to City's needs and to City's annual appropriation of sufficient funds in City's fiscal year (July 1st to June 30th) in which such Services are purchased. In the event City does not appropriate or budget sufficient funds to perform this Agreement, this Agreement shall be null and void without further action by City.
- 2. No Indemnification or Arbitration by City. Contractor understands and acknowledges that City is a municipal corporation that is funded by its taxpayers to operate for the benefit of its citizens. Accordingly, and pursuant to Oklahoma law, City shall not indemnify nor hold Contractor harmless for loss, damage, expense or liability arising from or related to this Agreement, including any attorneys' fees and costs. In addition, Contractor shall not limit its liability to City for actual loss or direct damages for any claim based on a breach of this Agreement and the documents incorporated herein. City reserves the right to pursue all legal and equitable remedies to which it may be entitled. City will not agree to binding arbitration of any disputes.
- 3. Intellectual Property Indemnification by Contractor. Contractor agrees to indemnify, defend, and save harmless City and its officers, employees and agents from all suits and actions of every nature brought against them due to the use of patented, trademarked or copyright-protected appliances, products, materials or processes provided by Contractor hereunder. Contractor shall pay all royalties and charges incident to such patents, trademarks or copyrights.
- 4. General Liability. Contractor shall hold City harmless from any loss, damage or claims arising from or related to the performance of the Agreement herein. Contractor must exercise all reasonable and customary precaution to prevent any harm or loss to all persons and property related to this Agreement.
- 5. **Liens.** Pursuant to City's Charter (Art. XII, §5), no lien of any kind shall exist against any property of City. Contractor agrees to indemnify and hold the City harmless from all claims, demands, causes of action or suits of whatever nature arising out of the services, labor, and material furnished by Contractor or Contractor's subcontractors under the scope of this Agreement.
- 6. **No Confidentiality.** Contractor understands and acknowledges that City is subject to the Oklahoma Open Records Act (51 O.S. §24A.1 et seq.) and therefore cannot assure the confidentiality of contract terms or other information provided by Contractor pursuant to this Agreement that would be inconsistent with City's compliance with its statutory requirements there under.
- 7. **Compliance with Laws.** Contractor shall be responsible for complying with all applicable federal, state and local laws. Contractor is responsible for any costs of such compliance. Contractor shall take the necessary actions to ensure its operations in performance of this contract and employment practices are in compliance with the requirements of the Americans with Disabilities Act. Contractor certifies that it and all of its subcontractors to be used in the performance of this agreement are in compliance with 25 O.S. Sec. 1313 and participate in the Status Verification System. The Status Verification System is defined in 25 O.S. Sec. 1313 and includes, but is not limited to, the free Employee Verification Program (E-Verify) available at www.dhs.gov/E-Verify.

- 8. Right to Audit. The parties agree that books, records, documents, accounting procedures, practices, price lists or any other items related to the Services provided hereunder are subject to inspection, examination, and copying by City or its designees. Contractor shall retain all records related to this Agreement for the duration of the contract term and a period of three years following completion and/or termination of the contract. If an audit, litigation or other action involving such records begins before the end of the three-year period, the records shall be maintained for three years from the date that all issues arising out of the action are resolved or until the end of the three-year retention period, whichever is later.
- 9. Governing Law and Venue. This Agreement is executed in and shall be governed by and construed in accordance with the laws of the State of Oklahoma without regard to its choice of law principles, which shall be the forum for any lawsuits arising under this Agreement or incident thereto. The parties stipulate that venue is proper in a court of competent jurisdiction in Tulsa County, Oklahoma and each party waives any objection to such venue.
- 10. **No Waiver.** A waiver of any breach of any provision of this Agreement shall not constitute or operate as a waiver of any other provision, nor shall any failure to enforce any provision hereof operate as a waiver of the enforcement of such provision or any other provision.
- 11. Entire Agreement/No Assignment. This Agreement and any documents incorporated herein constitute the entire agreement of the parties and supersede any and all prior agreements, oral or otherwise, relating to the subject matter of this Agreement. This Agreement may only be modified or amended in writing and signed by both parties. Notwithstanding anything to the contrary herein, the City does not agree to the terms of any future agreements, revisions or modifications that may be required under this Agreement unless such terms, revisions or modifications have been reduced to writing and signed by both parties. Contractor may not assign this Agreement or use subcontractors to provide the Goods and/or Services without City's prior written consent. Contractor shall not be entitled to any claim for extras of any kind or nature.
- 12. **Equal Employment Opportunity.** Contractor shall comply with all applicable laws regarding equal employment opportunity and nondiscrimination.

The undersigned Respondent agrees to the inclusion of the above provisions, among others, in any contract with the City of Tulsa.
