Policy Statement

Background Information

On March 14, 2018, the Council adopted Ordinance No. 23883, and the Mayor approved Ordinance No. 23883 on March 19, 2018 which created and named Tax Increment District No. 12, a tax increment district previously established by the ordinance adopting the Downtown Area Economic Development Project Plan. It was subsequently discovered that there was scrivener's error in the legal description of TIF "H" in Exhibit C to the Downtown Area Economic Development Project Plan and a corresponding error in the legal description of Tax Increment District No. 12 in Ordinance No. 23883.

Summation of the Requested Action

This Ordinance corrects the scrivener's error found in the legal description of Tax Increment District No. 12 in Ordinance No. 23883. For convenience, this Ordinance corrects the error by providing a replacement legal description for Tax Increment District No. 12. Adoption of this Ordinance by City Council and approval by the Mayor is requested.

ORDINANCE NO. 23962

AN ORDINANCE AMENDING AND CORRECTING ORDINANCE NO. 23883, APPROVED BY THE TULSA CITY COUNCIL ON MARCH 14, 2018 AND APPROVED BY THE MAYOR ON MARCH 19, 2018, WHICH NAMED INCREMENT DISTRICT "H" AS INCREMENT DISTRICT NO. 12, CITY OF TULSA AND IN WHICH SECTION 10 OF ORDINANCE NO. 23883 CONTAINS SCRIVENER'S ERRORS IN THE LEGAL DESCRIPTION OF INCREMENT DISTRICT NO. 12; CORRECTING AND CLARIFYING THE LEGAL DESCRIPTIONS IN SECTION 10 OF ORDINANCE NO. 23883; REPEALING THOSE PARTS OF ORDINANCE NO. 23883 IN CONFLICT HEREWITH AND DECLARING AN EMERGENCY.

WHEREAS, following procedures prescribed by the Oklahoma Local Development Act, 62 O.S. § 850, et seq., the Tulsa City Council adopted the Downtown Area Economic Development Project Plan on December 13, 2017, by Ordinance No. 23832, and the Mayor approved Ordinance No. 23832 on December 18, 2017 which established and identified eight tax increment districts and deferred the creation and naming of seven tax increment districts, including Increment District "H"; and

WHEREAS, Ordinance No. 23883 created and named Increment District "H" as Increment District No. 12, City of Tulsa, which Ordinance was approved by the Tulsa City Council on March 14, 2018 and approved by the Mayor on March 19, 2018; and

WHEREAS, Section 10 of Ordinance No. 23883 contains scrivener's errors in the legal description of Increment District No. 12, City of Tulsa; and

WHEREAS, Section 10 of Ordinance No. 23883 should be amended to correct and clarify the legal description of Increment District No. 12, City of Tulsa; and

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF TULSA:

Section 1. That the legal description of Increment District No. 12 in Section 10 of Ordinance No. 23883 be and the same is hereby amended to read as follows:

Increment District No. 12 Increment District "H" [Greenwood TIF District]

Beginning at the SE corner of Lot 3, Block 55, Tulsa-Original Town, thence northerly along the eastern boundary of Block 55 to the NE corner of Lot 1, Block 55, Tulsa-Original Town. Thence westerly along the northern boundary of Block 55 to the NE corner of Lot 1, Block 56, Tulsa-Original Town. Thence northerly along Lots 3 through 1, Block 44, Tulsa-Original Town to the NE corner of Lot 1, Block 44, Tulsa-Original Town. Thence continuing northerly along the eastern boundary of Block 25 and Block 22 for approximately 690 feet to the southern edge of EB E NIDL EXPY. Thence continuing along the southern edge of EB E NIDL EXPY in an easterly direction for approximately 2059 feet to the SE corner of Lot 4, Block 52, Tulsa-Original Town. Thence westerly along the southern boundary of Blocks 52, 53 and 54. Tulsa-Original Town to the SE corner of Lot 3, Block 55, Tulsa-Original Town and the point of beginning;

Less and Except:

Lots 1 through 3, Block 54, Tulsa-Original Town and Lot 4 & vacated alley ADJ ON E, Block 54, Tulsa-Original Town.

- Section 2. If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held invalid or unconstitutional, such portion shall not affect the validity of the remaining portions of this Ordinance.
- Section 3. That all portions of Ordinance No. 32883 in conflict with this Ordinance be repealed.
- Section 4. That an emergency is hereby declared to exist for the preservation of the public peace, health, and safety, by reason whereof this Ordinance shall take effect immediately upon its adoption and approval.
