## To Become: PAVEMENT MARKINGS AND SIGNS OPERATOR I (LT-16)

**EDUCATION:** Graduation from high school or possession of a General Education Development

(GED) Certificate

**EXPERIENCE:** Three (3) years' experience in general maintenance or construction work

LICENSES/

CERTIFICATIONS: Possession of a valid Oklahoma Class "D" Operator's License

#### 1<sup>st</sup> Proficiency Increase:

An increase to the next step within the LT-16 pay grade will be awarded to any Pavement Markings and Signs Operator I with six (6) months as a Pavement Markings and Signs Operator I and who successfully:

Obtains a Class "B" Commercial Driver's License (CDL) with applicable endorsements; and

Completes one (1) class in either Work Zone Safety as pre-approved by the Department or one (1) approved Safety Training progression credit; and

Receives a "Proficient" rating on most current performance evaluation.

### 2<sup>nd</sup> Proficiency Increase:

An increase to the next step within the LT-16 pay grade will be awarded to any Pavement Markings and Signs Operator I with nine (9) months as a Pavement Markings and Signs Operator I and who successfully:

Passes an internal operator's exam, conducted by the Department, proving they can operate a bucket truck and platform truck for the installation of large mast arm signs, according to City of Tulsa specifications; and

Completes one (1) class in either Work Zone Safety as pre-approved by the Department or one (1) approved Safety Training progression credit whichever not taken for 1<sup>st</sup> proficiency above; and

Receives a "Proficient" rating on most current performance evaluation.

To Become: PAVEMENT MARKINGS AND SIGNS OPERATOR II (LT-17)

**EDUCATION:** Graduation from high school or possession of a General Education Development

(GED) Certificate

**EXPERIENCE:** Four (4) years' experience in general maintenance operating specialized

equipment, including one (1) year of experience as a Pavement Markings and

Signs Operator I with the City of Tulsa for internal progression candidates.

**TECHNICAL** 

KNOWLEDGE: Employee must demonstrate significant knowledge and understanding of the

Manual on Uniform Traffic Control Devices (MUTCD) by passing an internal exam.

**TRAINING:** Internal: Two (2) progression credits from an internal City source(es), not

previously taken, from the following choices:

One (1) progression credit from the communications or human

relations group

One (1) one progression credit in Safety Training

**External:** One (1) seminar or workshop approved by the Department

**LICENSES AND** 

**CERTIFICATIONS:** Possession of a valid Class "B" Commercial Driver's License (CDL).

**DEMONSTRATED** 

SKILL PROFICIENCY: Receives a "Proficient" rating on the most current performance evaluation

#### 1<sup>st</sup> Proficiency Increase:

An increase to the next step within the LT-17 pay grade will be awarded to any Pavement Markings and Signs Operator I with one (1) year as a Pavement Markings and Signs Operator II and who successfully:

Passes an internal operator's exam, conducted by the Department, proving they can operate the long-line striping truck to apply both skip and long-line stripes to the roadway according to City of Tulsa specifications and to use the hand-liner to apply crosswalk markings to the roadway according to City of Tulsa specifications; and

Completes one (1) Stormwater Operator Certification Class as pre-approved by the Department; and

Receives a "Proficient" or above rating on most current performance evaluation.
